My thoughts on this is that we should proceed with the initial alignment, because:

- The proposed alternative is not meeting demand according to our analysis
- While I take the point about the crossing, it too is in an area of low demand and therefore we can't justify spending £100k on it
- Should the Brent Cross to Chipping Barnet route be progressed (referred to as 'Dollis Valley Green Walk' in phase 2.3) I think this would be the time to look at the spur / connection

What do you think?

As you know we are going through a programme reprioritisation. Let's catch up about what this might mean when you're back in the office.
