SV completed 16/10/19 to determine whether extension was obver approved 4 metres in height. measurements taken from top of roof (where it elevates) to ground floor was roughly 3.99 metres. (there were three measurements taken 3.98, 3.99 and 4 metres divided by three is 3.99 metres), after reviewing the plans and discussing them with builders it has been confirmed that .11 mm will need to be added to the height based onthe OSB board and -.22 mm will be subtracted once the land is raised as indicated. This would put the final height at 3.88 or thereabouts. There is no breach at this time. I am recommending the case be closed.

I refer to your complaint regarding a possible breach of planning control at the above address. I can inform you that the investigation has confirmed that no breach of planning control has occurred. I did conduct a site visit to the property in October and was able to complete all necessary measurements on the rear extension. Measurements were taken from the top of the elevated roof to the ground floor several times. The average of the measurements was roughly 3.98 metres. The approved plans for the extension was 4 metres.

After reviewing the plans and discussing the further works to be completed with the builders on site, I have recommended that the case be closed at this time as there is no breach in planning control.

Site Inspection
completed SV 16/10/19 to the property and met with owner regarding the concerns with the height of the rear extension being built
outside of approved plans 19/2222/HSE for Single storey rear extension. Alterations to roof of existing single storey rear extension. Alterations to fenestration.

I took measurements of structure with the helps of the builders currently on site. The approved plans provided a height of 4 metres from ground level to top of roof and 3 metres from ground to the top of the eaves.

The ground at the site has yet to be leveled and there are plans in place to do so after construction to the extension is completed. Measuring from the bottom of the ground as is to the top of the eaves is roughly 2.9175, (4 measurements were taken 2.99; 2.78; 2.89; 3.01 and divided by 4 for the mean)
measurements taken from top of roof (where it elevates) to ground floor was roughly 3.99 metres. (there were three measurements taken 3.98 , 3.99 and 4 metres divided by three is 3.99 metres), after reviewing the plans and discussing them with builders it has been confirmed that . 11 mm will need to be added to the height based onthe OSB board and .22 mm will be subtracted once the land is raised as indicated. This would put the final height at 3.88 or thereabouts.

Measurements of the length of the rear extension is 6 metres, which is provided in the approved plans.

I have taken photos for evidence. Based upon my measurements I will recommend that the case be closed as NFA.
