I'm looking for some information regarding the Brent Cross Transfer Station, being constructed in joint management with Barnet County Council and NLWA. I would like to know the three short listed bidders for the tender.

We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we believe that the exceptions detailed below apply to all the information you requested and so we are withholding that information. Please see the Refusal Notice below.
