The conversion of the Hippodrome to an Islamic centre (Place of Worship / Mosque?) - intending to be one of the largest in Western Europe, according to its website would require significant change to the interior of the iconic Grade II Listed Building.

A Mosque has no need for theatre seats, it merely requires floor space to accommodate the large number of worshippers, which would require the removal of the seats.

The Hippodrome can accommodate up to 3,200 people but has parking for only 30 vehicles - the resulting additional traffic from its visitors, seven days a week would mean a significant increase to traffic to Golders Green, which is already congested; the surrounding streets will become one gigantic car park. Parking is already a major problem in the area; including driveways being blocked during the unauthorised use of the Hippodrome following the enforcement notice by Barnet Council (April 2019).

In addition, extended opening hours, from 8AM to 12:30AM would cause severe disturbance late at night, with traffic and people noise, to the local population, especially with the limited available

public transport.

Prior to planning being granted for the change of use, prayer mats have already been laid out in what were the stalls (Guardian 15/1017) in total disregard to planning consent - a sign of things to come?

In summary, we believe that the Hippodrome should be returned to being a public facility to be used by all faiths and non-believers alike. The Hippodrome should be preserved as a public amenity in its original form, not as an edifice for a particular religious group - fully protected by a preservation order.

The conversion of the hippodrome into a one of the biggest Islam centres in Europe capable for up to 3200 people in an area thats heavily congested and with no parking facilities is not viable.

Golders Green is already heavily congested despite recent attempts to upgrade infatructure.

There are very little parking facilities already in Golders Green, and it's already hard to park if you want to go to the local shops

Putting in a mosque will increase the traffic congestion, the competition for limited parking which will impact local shops and the overall pollution.

For locals who live in the area having up to 3200 people or even half of that descend on what is a suburban family area will have a detrimental impact on the quiet enjoyment of all the roads around the area suffering from parking issues and increase footfall. As do similar areas near stadiums who have to put parking restrictions up on match days.

There is no obvious heavy concentration of Islamic community in the area so the majority of people will be travelling via car.

It would make more sense and benefit to house one of the biggest Islamic centres of worship in an area with a higher concentration of Islamic community, as they would benefit more and the impact on congestion would be less as they would be able to walk.

There is also a big shortage of policing in the Barnet area at the moment so pulling on these resources to assist with traffic policing will be a further drain in resources.

Hampstead Garden Suburb is also a conservation area so it would be nice to maintain the building for the arts as was intended.

Comment:We live in a road adjacent to the site and are concerned with the problems which were caused by poor parking and late night disturbance when the 'Mosque' first opened, some months ago. Although the plan provides considerable detail on the forecast travel data and the planned controls and periodic monitoring of the congregation's travel arrangements, there is no guarantee that swift action would follow if the forecasts turn out to be incorrect in practice. In the meantime local residents could be inconvenienced and upset.

Allied to the above are the late finishing hours shown for many of the activities, which could lead to late night noise and disturbance in the local residential streets.

The plans to make it 'among the largest Islamic Centres in Europe' doesn't appear to fit well with the religious ethos of the area. It seems somewhat out of place, for such a significant Islamic centre.

The previous tenants were also a religious group who fitted in well into the area but had nothing like the size of congregation being projected in this case.

I happened to notice one minor inaccuracy in para. 4.2 of the 'Site Location and Operation' section, where it states that 'the A502 meets the A406, North Circular Road' approximately 100 metres NW of the site. I don't know the actual distance but it must be more like a mile!

- 1. Golders Green and Hampstead are conservation areas. The mosque will dominate the area and be completely out of character. This beloved Grade II listed building is an arts and performance space for all, not for just one part of the community. The application will get rid of concerts, conferences, drama and dance. It will irreversibly harm the building's artistic heritage, local character and people's amenities.
- 2. Congestion and Parking. At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, the residents lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.
- 3. Disturbance. Residents reported constant disturbance until after midnight: car doors slamming, engines revving and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason:" to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions.

I am highly against this. I speak for many.
