The proposal that 80-100 visitors will attend every evening, and up to 1400 during festivals per year (which will continue until 11-11.30 pm) carries a high risk of adverse impact (through both congestion and noise) on the residential roads close to the Hippodrome.

The Travel Plan describes the excellent access of the venue to public transport, but also notes that '133 spaces are available along single yellow lines that can be accessed over night'. All such spaces are already largely occupied by visitors to Golders Green's restaurants and other amenities, as well as cars parked to make use of the tube in the evenings. The yellow lines do not represent vacant space available for a new use. The travel survey included within the Travel Plan involved 210 regular users, but showed that only 13 (6%) respondents live within a 15-25 minute walk of the venue. Many regular attendees may therefore find driving a convenient option; and for festivals, it cannot be assumed that the much larger number (up to 1400) of attendees will come from locations that would make return by public transport possible after 11 pm.

The 2007 planning permission explicitly cites use of the building "as a church to enrich the community with schemes....to hold concerts, conferences, drama and dance festivals". This planning condition suggests that such events are for the whole local community and not just for the individuals attending the church. Buses and taxis struggle with the traffic in and around the roads and traffic flow system, with may pedestrian crossings and traffic lights. There are also several schools in the area and this makes the congestion worse at school drop off and and pick up times.

With planned hours of operation 8am to 11pm 365 days a year and an unlimited 3,000 capacity the extra cars and traffic in the area would be extremely impactful. There is also no planned Hippodrome car park and very limited extra on-street parking so this would likely increase poor parking habits and congestion in the surrounding areas.

I have been a resident in the area for the past 25 years. But above all, in this day and age, individual religious practice should be a private affair, to be practiced in an individual's private home. One does not need to go to a specific place to reach out to God.



I write with regard to the planning application at the sight known as Golders Green Hippodrome on North End Road, London NW11.

My reasons are as follows:

This building is at the heart of a traffic hub and there is already substantial vehicle congestion in the area.

In particular the route from the Royal Free hospital - the nearest A&E and largest hospital in the area - to the heart of Golders Green and on to both Hendon and Finchley runs directly past this building and further enhanced congestion is a real danger to the emergency services.

We have seen as a result of the Covid pandemic the amount of ambulances with blue lights on the area and nearly ALL have to pass this building to either get to a residence or return to the hospital.

The amount of potential people that may visit this building on a daily basis will certainly cause logistical problems in the area and given that it is a maor transport hub for coaches going to the motorway (c 1 mile away) and then setting off to 2 airports and also to central London cannot only be seen as very disruptive and has the potential to cause utter chaos.

Let me be clear my views would be for the same if this site was being used for other purposes housing a large capacity which then would cause similar disruption.

In addition, it should not be ignored that you cannot compel those who visit the area from outside to use public transport and given the proposed usage it is likely they will not. Therefore there will for sure be a huge increase in traffic from out of the area.

I am also not persuaded that the local shops would materially benefit from people coming from outside and visiting the area. Indeed, if locals cannot get to the shops because of traffic problems caused by this change of use, it will have a detrimental effect on those businesses as well.

Perhaps a building with purposes required for substantial visitors should look to set up in the empty retail parks where there is also substantial parking and are areas which are already planned for many visitors.
