





Dear Sir

I am most concerned at the proposal that Golders Green Hippodrome should be used as a mega mosque.

I am a long standing resident of Golders Green, and regularly use the Underground station. I regularly walk past and drive past the building on North End Road. I also use the side roads - West Heath Avenue and West Heath Road.

I remember going to the Hippodrome as a child and teenager years ago to see pantomimes, musicals and plays.

I am most concerned to hear that the present owners have ignored enforcement notices for several years, which would have restricted their use of the building.

It is quite clear that granting permission for use of the building as a mega mosque would vastly increase its usage and resultant vehicular traffic. Given the Owner's track record of ignoring the Council's enforcement notice, it is quite clear they would be even less inclined to comply with any limiting conditions of a planning approval. The Council would be accepting a use which they would be powerless to control in the future.

Indeed the word "mega" by definition implies intensive and large scale use. Should this be allowed to happen, it would be in complete contrast to the rather sedate and confined use of the premises over the past decades.

In recent years the area has become much more congested with increased traffic, causing greater levels of pollution.

The number of people milling around the station and the surrounding area has increased. We also know from personal experience that undesirable young men have often been loitering around the area, causing many local teenagers to have to go elsewhere to access public transport.

The police have told us that there has also been an increase in people selling drugs in the area.

If the Hippodrome becomes a mega mosque, it will obviously attract very large numbers of visitors, as that is its purpose. There will be frequent occasions when the area will become almost impassable to local residents and the quality of life locally will be disrupted.

From a building heritage point of view, I would not wish to see any features of the building altered, as this would detract from the ambience of the area.

I therefore hope you will reject the application and prevent the Golders Green Hippodrome from being used as a mega mosque.


I have heard about the plans to build an Islamic mosque in the Hippodrome in Golders Green.



is a residential road occupied by elderly people and many families with young children. It is not wide enough for cars coming from both directions to pass when parking is on both sides of the road. When the building by the present occupiers was in constant use prior to the pandemic restrictions, we residents were plagued by selfish inconsiderate parking. We had days of constant traffic jams and being unable to reach our homes. Cars were parked on both sides of the road, across driveways, garages and on yellow lines. On one occasion it took us nearly 15 minutes to drive about 30 yards from North End Road to our house only to find that a parked car had blocked the entrance to our drive. We are aware of similar incidents in West Heath Drive and Golders Park Close. We had to call the traffic enforcement team on several occasions to deal with the problems. We are local resident and have lived in the area for more than 5 years. I believe that these plans will negatively impact the local area and quality of life for all residents. Since the planned mosque is not planned to serve mainly a local community, there will be a massive increase in traffic and congestion, for an area that is already highly congested. There will also be an increase in pollution and a general disturbance due to noise (especially at night). Last year during the Ramadan period many people from outside the borough were driving to the centre and there was increased congestion, illegal parking, late night noise and disturbance and lack of parking and access to local amenities for the residents. This type of structure by its nature will attract, on a daily basis, many non-residents to the detriment of the wider community living and working in the area.







OBJECTION TO THE ABOVE PLANNING APPLICATION

I wish to object to the owners above planning application. There is already an appeal pending against the owners previous planning application. This is an attempt to get around the appeal process. This application should be refused and any appeal settled by the Planning Inspectorate with the appeal already pending. As the Council is aware this is a controversial planning application and should be refused.

Th subject property is a Grade II listed building and in two conservation areas. It's use is intended to be as an artistic space for all and not just one community to be used as a mosque. A mosque at this site would be dominant and out of character and permanently alter the heritage of the two conservation areas. Conversion to a mosque would also put an end to concerts, drama and dance - things for which this Hippodrome is well known.

Given the size of the premises and the intended scale of use of the property as a mosque (intended to be the largest Islamic Centre in Europe and bigger than the mosque at Finsbury Park) is resulting in and will continue to result in heavy congestion and parking problems. The area is already a heavily congested area. With late openings this would encourage people to come by cars to an already heavily congested area. This would make the position impossible and totally intolerable for the neighbours, businesses and residents. The lack of parking makes traffic and congestion unmanageable at this sensitive, central location, increasing the already twice the legal limit for NO2 toxic emission levels. Traffic congestion and parking on double yellow lines have been continuous. Residents lives are being adversely affected by the continuous congestion and illegal parking and the heavy intensity of use.

The hours of use and the resultant noise (slamming car doors, revving engines - when people are asleep/trying to sleep) and total disregard by the visitors of the neighbours well until after midnight causes constant disturbance to the residents and is affecting the quality of their lives. The planning condition imposed in 2007 was for this very reason - to safeguard the amenities of the area.

The owners have already demonstrated that they will blatantly ignore planning conditions . Therefore none of these objections can be addressed by the imposition of planning conditions.

At the time of purchase of the property, the owners would have been well aware of the planning restrictions on this property and by making the purchase they have intended all along to act in flagrant breach of planning and in total disregard of the neighbours and the neighbourhood.

I am writing in my capacity on behalf of the synagogue council and congregation to express our full support for this application.

This application should be a straightforward matter. The Markaz is applying to use the building for exactly the same purpose as the previous occupants, El-Shaddai Church. This is not a change of use, except insofar as they are a Muslim organisation rather than a church. They intend to use the building as a community centre, a place of worship and for performances. They are not intending to make any physical changes to the building whatsoever. It seems inconceivable that they would be denied the use of this building because they are a Muslim rather than a Christian organisation.

It is understandable that local residents have raised concerns about the impact on the local neighbourhood, in particular in relation to parking. It is difficult to imagine any appropriate use for the Hippodrome, a landmark listed building at the heart of Golders Green, which would not involve large numbers of people travelling to use it on particular occasions and at peak times. A building constructed as a concert hall ought to be used for events and activities which draw large numbers of people. The Markaz has provided a full transport plan. It's difficult to imagine a location better served by public transport, sited as it is directly next to a bus station and tube station. This community has been based in the local area for many years, so they will be drawing largely on people who are already in the area.

It is absolutely appalling that the self-styled 'mosque buster,' has been retained to oppose the use of the building. I hope that the council is looking into his links to the extreme right and the quesiton of how his involvement is being funded. It is condemned out of his own mouth as an extreme Islamophobe. His advice to his supporters as to how to oppose planning permission for any Muslim institutions is that they should seek to oppose it on the basis of legitimate planning grounds and disguise themselves as local amenity groups, focusing on issues like parking. He can easily be

found online offering this advice. No doubt there are local residents with legitimate concerns about parking, but there are also local residents whose fears about the consequences of the presence of the Markaz are based on a hate campaign of egregious misinformation and others who are utterly cynical in advancing parking concerns because they are anti-Muslim.

This has been a convoluted and protracted planning process. I fear that the concerns of the council about the possible politicisation of this decision have led to an attitude of extreme, possibly even excessive caution, and that the consequence of this has been that this community have, in effect, been put through huge stress and delay and put to great expense and subject in effect to discrimination because they are a Muslim institution. I am aware that a number of the elderly trustees of the Markaz are not well and that this protracted process has had a negative impact on their health. The community has received hate male and been subject to racist harassment. The delays in the planning process have contributed to the demoralisation of this community. It would be an indelible shame if they were driven out of Barnet in effect because of Islamophobia.

The Markaz are our friends. Like us, they want to exercise their right as members of a minority religion to meet and assemble and to worship freely and without discrimination and harassment. Like us, many of them and their families have arrived in Barnet within living memory as refugees from opporession and discrimination elsewhere.

There can be no legitimate planning basis for continuing to deprive this community of the opportunity to meet and to use their building. We fully support their application and appeal to you to approve it.

I am writing to object to the above planning application for the following reasons:

- 1. Negative impact on traffic and parking, increased congestion and pollution
- 2.Diminishing of a local community amenity instead of strengthening community cohesion

I will now give my reasons for the objections:

1. Negative impact on traffic and parking, increased congestion and pollution

When the Hippodrome was previously used as a place of worship one of the results was that parking for residents and shoppers was difficult. It was impossible to park in Sainsbury's car park if you had a heavy load of shopping and at that time Sainsbury's put restrictions in place in recognition of the use of their car park as parking by the worshippers not shoppers. There is not enough parking spaces for residents and the parking spaces near Golders Green park are usually full at weekends and other times. Additional traffic in the area would impact negatively on those who use Golders Green for their shopping, recreation, health and wellbeing. More cars parking and driving through the neighbourhood would be to the detriment of current residents, people who use local shops and those who use the park facilities.

The Travel Plan shows on page 18 Table 6.1 that, when the survey was taken, that 32% of journeys are by car, Although the aim is to reduce to 10% that is ambitious target considering that the majority of the 170 respondents lived within a 45 minute public transport distance from the Hippodrome and that the aim is to reduce to 10% over 5 years. Meanwhile use of taxis will be promoted in the travel plan again causing congestion at an already very busy roundabout at the Clock Tower and a major terminus for bus and coaches. The majority of users of public transport will be using it at the peak hours of 18.00 to 20.00 and 21.00 to 23.00 on Fridays (page 18, para 6.2 of the Travel Plan). It is already virtually impossible to drive along the Finchley Road to the North Circular via Temple Fortune during a Friday rush hour and there will be increased noise from people

leaving the Markaz at 23.00 with increased use of cars, taxis and public transport. This will be to the detriment of local residents and users of local facilities. The roads around the Clock Tower are already a pinch point, there is no further capacity for increased pedestrians or traffic. The likely attendance of 1,400 people on seven occasions per year in addition to other planned events of expected attendance of 500 per event will be detrimental to local facilities and local residents.

The Planning Statement (para5.5.4) states that there are showering facilities in the building for cyclists, but due to the lack of labelling on the plans it is not possible to see if there are showers for males and for females, presumably equal opportunities would require both so thatthe trvel plan can be promoted equally to both males and females.

There is a wide range of activities planned as detailed in the Public Performance Management Scheme (in addition to the annual calendar), and large numbers may attend, these include weddings, large screen showings of football matches which may cause further congestion on top of the annual calendar of religious festivals.

The Planning Statement para 5.4.6 claims that there are cycle routes and cycle parking with capacity in proximity to the site. in fact there are no marked routes for cyclists near the Clock Tower or cycle parking. The plan is to include 58 cycle parking spaces externally (para5.5.4 Planning Statement) but it does state where these will be or if the local community or general public will be able to use them or if this will cause further congestion and hazards on the pavement causing obstructions for pedestrians, wheelchair users or people with buggies etc.

The increased use of the Hippodrome by large numbers will increase potential conflict between cyclists, pedestrians and vehicles, and it should be noted that there is an extremely high number of buses and coaches which are circulating around Golders Green.

I am not convinced or confident that there will be proper monitoring by Barnet Council of the Travel Plan or sufficient penalties if targets are not met.

For all the above reasons I consider that the proposal will be detrimental to Golders Green.

2. Diminishing of a local community amenity instead of strengthening community cohesion

Although the activities Public Performance Management Scheme listed state that non-Moslems are welcome to attend theactivities there is no equal opportunities statement supporting the access of all people regardless of creed, sexual orientation, gender or disability etc. nor confirmation that the events will be fully inclusive. indeed the Public Performance Management Scheme has been replicated from the application in 2007 (para 5.3.10 of the Planning Statement) ,therefore it may not actually reflect the vision and aims of the current owners of the Hippodrome or their commitment to the actual implementation of the Public Performance Management Scheme. For example the daily nursery planned will require specific facilities for younger children, i.e. toilets at a suitable height for children, facilities for staff, storage area for play equipment and an outdoor play area for example if it is to meet Ofsted criteria. The submitted plans are not labelled so it is not possible to ascertain if indeed the day nursery is seriously planned for or has been included in the list of activities in the

application as token compliance because the planning permission was previously granted with this or a very similar scheme.

Although permission was granted in 2007 for the Hippodrome to be used as a church it was not an asset to the local community and caused congestion and difficulties in parking. To the best of my knowledge no local community events took place. Since 2007, thirteen years ago, we are more aware of the impact of increased traffic on the health and wellbeing of local children and residents and our understanding of what a fully inclusive community looks like has also developed. What may have been acceptable over a decade ago is in many respects outdated, therefore the expectations of the local community will have moved on too. Consider the call for rights of transgender and gay community and equality for women in all strata of society. Any application that assumes that what was appropriate in 2007 is still appropriate will not be delivering increased community cohesion or inclusive practices but will be reverting to the token plans of a previous occupants without any commitment, but as a ploy to obtain planning permission. I therefore do not think that the will be benefit to the amenities local community from the Public Performance Management Scheme.
