Planning Application 20/2988/FUL Golders Green

I write to object to the consent of this application for the following reasons:

- 1) When the Hippodrome was originally for sale, Jewish cultural societies applied to turn the site into a Cultural Centre for Jewish study. The application was turned down for the explicit reason that the site was to be used for all races, religions and none, for the benefits of all, who wished to use the site as a place for learning. The Jewish cultural centre was subsequently built on the Finchley Road near the 02 Centre. If the Hippodrome is now permitted to become a religious place of worship, for one religion in particular, then this demonstrates a clear discrimination against the Jewish faith. This would be particularly difficult to accept, as there is a large Jewish community in the vicinity of Golders Green.
- 2) The site of the Hippodrome is very close to the underground and bus terminus that naturally causes large groupings of people, car parking, travelling, using taxi's etc., to the point of saturation, and is already causing daily traffic jams, carbon pollution, and noise in a relatively small area. Any place of worship in this area, would add to this already chaotic mix of humankind, traffic and pollution to the detriment of all other races and religions save, for the benefit of one.
- 3) There are many children that arrive by bus or coach to Golders Green, there, to travel onward to their respective homes, and necessitates them crossing the roads, walking around the


already crowded area, and any additional pressure upon the population with reduce the safety of those children travelling to or from school. the streets remain clean, and that children and the elderly can walk about the area safely. Who is going to pay for that?



The proposed plan to enlarge the building removes any opportunity for any other development which does not have such a great effect on people, motor vehicles and bus traffic. This area is already a congested area, with a bus station, an underground station and a busy and important crossroad for vehicle traffic going north, south, east or west. If any large event or festival was held at an enlarged place of worship for over 2000 people, as suggested in the plans, the traffic delays due to car and bus traffic could materially affect a large part of north-west London. The carbon footprint, the noise and the stress for Londoners not attending such an event could be great. It could be considered unreasonable for any Council to allow one place of worship to have such an effect on an area on a regular basis.

Furthermore, I believe that many of worshippers at this place of worship do not live in this area and would need to cycle, drive or take a bus to get to this place of worship. Transport to and from this site as well as parking is already an issue for this area. Enlarging this place of worship would most probably worsen this issue. The plan states that there could be between 500 and 2000 people attending some events. I do not believe that this parking issue, during the day and in the evening, has been considered properly in the plans.

From events that have taken place since this has become a place a worship, I believe that parking issues have already arisen and the residents in close proximity of this place of worship, have been affected by air and noise pollution, during the day and at night. Any expansion of this place of worship would most likely increase this pollution, in an area where there is already sufficient pollution from the current traffic levels.

I also am under the impression several genuinely local bodies applied to occupy the building and use it as schools or whatever else and were turned down. I do not understand how they were refused yet there is a possibility you would bend the rules for the current owner.

The current owners of the Hippodrome previously ran a mosque in Kilburn if I'm not mistaken. There are plenty of Muslims in Kilburn so it was natural for them to want a

mosque there. I do not believe there are many Muslims in NW11 so why do they wish to have a mosque there? There are rumours that it is to be not only a mosque but eventually a Super-mosque to compete with the one at Finsbury Park.

Things are difficult enough for local residents who need to go to Golders Green for food shopping, doctors and dentists etc due to congestion and the constant flow of people coming and going. This will be further exacerbated by a large influx of non-residents coming to Golders Green several times a day. Needless to say there will be extreme pollution and densification, and a drain on services without any benefit to the local community. 
