The hippodrome has been in place since the early 1900's and was set up as a place of entertainment to be enjoyed by the whole Community. It is regrettable that since 2007 it was taken over by one segment of the Community which precludes use as a centre of entertainment for the general public. The loss of this facility is very upsetting, but it would be aggravated considerably if this planning permission would be given the green light.

The main cause of concern is the total lack of parking facilities anywhere in the area. Currently, local residents have to hunt around for a free spot to park their own cars, and this is hopelessly inadequate. For the Hippodrome to get a licence to hold large prayer meetings would mean absolute nightmare and total chaos in the surrounding area. Golders Green is a very crowded centre with narrowish streets. Already there is not enough parking space and roads get congested. Even if the majority of the 3,500 worshippers come by public transport the additional cars will cause a huge nuisance to local inhabitants having an effect on their mental health. Worshippers will have to drive round and round scouring the streets for parking spaces. Already high pollution levels will rocket.

My second big objection relates to ambulance access. Extra cars and hordes of people coming into and out of the mosque could really delay ambulances. These precious minutes could be the difference between life and death.

Golders Green was not built for the number of cars that currently drive in and through it. It would be a huge planning error to allow permission for a building for 3,500 participants.



Thank you for your letter regarding written representations on the appeal to The Secretary of State in response to the Enforcement Notice served by the London Borough of Barnet in relation to Golders Green Hippodrome, 3 North End Road, London NW11 7RP.

The Notice reference is ENF/0615/19.

The Planning Inspectorate Reference is APP/N5090/C/19/3229937.

I have lived in the Golders Green area for 38 years. It is a very special residential neighbourhood in a unique part of London, with Hampstead Heath and Hampstead Heath Extension (and Golders Hill park) providing great amenities to residents.

Golders Green Hippodrome is an iconic building with a considerable history. Its use has been protected by planning rules.

Over recent years, the planning rules have been ignored by the present owners and they have used the building unlawfully. They should be punished for this and not rewarded.

It is the duty of all planners who have a decision to take on this matter to ensure that this building is preserved for use by the community as a whole. It is quite wrong if the owners continue to use the building as a Mosque despite the Enforcement Notice.

Golders Green is a very mixed community. A huge Mosque in the centre of Golders Green would do great harm to the locality. It would damage the quality of life in the area. It would significantly affect road traffic safety and result in congestion, pollution (both air and noise pollution) and disturbance. Such a facility in the centre of Golders Green is wholly inappropriate.

You will be aware of constant disturbance which has been reported over the past couple of years or so when the Hippodrome has wrongly been used as a Mosque. The planning condition imposed on the building was "to safeguard the amenities of the area". Opening hours and other conditions have been ignored. It is quite clear that the use of the Hippodrome as a Mosque could not be controlled by the use of planning conditions.

In this broadly cosmopolitan Golders Green area, the creation of one of "the largest Islamic centres in Europe" would be wrong.






