Comment: The application relates to a change from one use to a similar one. There is also outstanding the appeal against the enforcement notice relating to the 2007 permission.

In both the enforcement notice and the current planning application the significant difference appears to be that the 2007 permission authorised use as a church and the current application is for use as a place of worship. It is well known that the place of worship is for Muslims instead of Christians. You would not expect that to be objectionable from a planning perspective.

I would ask the officers and committee members to assure themselves that in considering the matter they would make the same decision if the proposal was for a change of use from an Islamic place of worship to a Christian one.

The property is next door to Golders Green underground and bus stations. In addition there are within a few yards of the property several buses serving the area and beyond. it is difficult to think of any other location outside central London with better public transport links. That will reduce the need for on street parking and in any event the religious and community nature of the building will have remained constant since 2007 when permission was previously granted.

I object to the plan of using the Hippodrome as a mosque for the following reasons:

1. Golders Green and Hampstead Conservation Areas

The mosque will dominate the area and be completely out of character. It will be twice the size of Finsbury Park Mosque and comparable to Regents Park Mosque. The promoters have said they want it "To be among the largest Islamic Centres in Europe". This beloved Grade II listed building is an arts and performance space for all, not for just one part of the community. The application will get rid of concerts, conferences, drama and dance. It will irreversibly harm the building's artistic heritage, local character and people's amenities.

2. Congestion and Parking

At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.

3. Disturbance

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions. The problem would likely worsen if this planning permission went through.



Comment: The Hippodrome has been operating as an 'Islamic centre' for several years now - so we are familiar with it. The problem is clearly traffic and parking. There is very little parking at the site - 3/4 spaces - or near (10?), but the congregants mainly come from Cricklewood (I understand), where the mosque was originally sited, which as you know is inconvenient to Golders Green (as it is east/west) by underground (which is north/south), so naturally they drive, only to find nowhere to park. But this can be a busy commercial area in the evening with the restaurants, the LT bus station, the National Express bus station, the underground - and the Sainsbury's supermarket, whose deliveries (and customers) must make the turn from West Heath Drive down St Albans Lane. The lane is narrow, but all those restaurants have built kitchens out into their backyards - so they leave their bins on the road. Meanwhile the pavement is only 1 metre wide on one side (about 2ft the other) and so broken up and useless most pedestrians prefer to walk in the road. Sainsbury's juggernauts (and with other lorries/vans parked up to make deliveries to the restaurants) are all too often unable to make the turn. When the 'centre' is in operation the cars are parked on yellow lines along both sides of West Heath Drive (also to collect food). These juggernauts can only make the turn in a three/five/7-point manouevre to get round. If the cars are parked there they find it impossible. Then cars coming down (the steep hill of) North End Road to turn onto West Heath Drive get backed up as the road is blocked by cars making the turn where the trucks get stuck. The best place to park would be Sainsbury's, but they don't because there is only 1hour 'free' parking til 9pm. So there should be a condition they do a deal with Sainbury's for parking as this is unsustainable as it is now, and yet they say they want to build the biggest mosque in the UK. I think they might need a bigger site for that.

The area has changed, life itself has changed and people have changed and what might have been wonderful 60 years ago has already proved to be a disaster for the residents of today, and that's without The Hippodrome having being given permission for use as a House of Worship. So let us not forget, that whilst the Hippodrome seats 700 now, it can easily be reinstated to seat 3000, as it was originally built for. After all a Mosque, Church, or Synagogue, doesn't need a grand stage, which can easily be removed, it just needs a large enough arena to cope with the congregants and if as their own traffic proposal indicates that at peak times there may be as much as 2,200 people, you should really be prepared for 3000 people. If not now then in the very near future!

I am writing with regard to the above.

The loss of a such a remarkable building listed as "a rare example of a surviving suburban theatre, largely intact", for public theatre use is truly worrying.

The Hippodrome was built by renowned theatre architect Bertie Crewe in 1913 as a 3,000-seater musical venue.

It has staged performances and live concerts by legends including Danny La Rue and Marlene Dietrich.

It hosted two episodes of the first series of Monty Python's Flying Circus in October 1969.

Golders Green broadcaster and oral historian Alan Dein believes this is a key opportunity for the Hippodrome to fulfill its potential and become a "significant arts and cultural complex" once again.

Mr Dein described how after the Hippodrome was built in 1913, it "served up an incredible range of pre-and post West End shows, opera, musicals, pantomimes, jazz bands, ballet and even Rock and Roll".

The venue was then converted into a BBC TV and radio studio and a concert hall in 1969.

Mr Dein added: "The likes of Radio 2's 'Friday Night is Music Night' broadcast to the whole nation became part of Golders Green legend!"

The Hippodrome was sold to the evangelical El Shaddai International Christian Centre in 2007 they received permission to use the building as a church, subject to conditions.

Condition 3 of the 2007 planning permission positively required that the Hippodrome hold a large number of performances and entertainments each week and month. These were set out at page 6 of the 2007 Planning Officer's Report, as including:

Weekly (either once a week or every day depending on activity)

- · dance classes for children and youth; 3. drama groups;
- · instrument tuition;
- · single tuition;
- · children's and youth choir;

Special Events (Held Approx once a month)

- · Music concerts with visiting musicians;
- · Pantomimes;
- · drama performances held for children, including puppet shows, visiting theatrical groups etc.

There will also be activities for adults. These include Monthly

- · Concerts by visiting musicians/bands and orchestras;
- · Theatrical performances

Condition 3 states:

3. The applicants shall submit a public performance management scheme to be submitted to and approved in writing by the Local Planning Authority within three months of the date of this decision. The use and associated public performance activities shall be carried out strictly in accordance with the approved scheme.

Reason: To ensure an appropriate level of public performance for the benefit of the community.

The building was resold in 2017.

Currently the above Condition is being flouted by the new owners of the building. The previous owners, the El Shaddai International Christian Centre also failed to follow the Public Performance Management Scheme. I fail to see how, if the Barnet fail to enforce the current conditions that we can have any confidence that they will do so once the building is more intensively used, as is now proposed. Accordingly there has been and will be a substantial loss of performances and entertainments at this Grade II Listed theatre that forms the heart of this Conservation Area.

Like it or not the current application is a turning point because it will be the first time that the Hippodrome will change to a use without a substantial element of public performance. It is naive to think that since Condition 3 (above) of the 2007 permission will remain in place, then it will be enforced or is enforceable by Barnet - they have shown no appetite for enforcement of this condition in the past.

It would be very straight forward for Historic England/Barnet to simply require the applicant to produce a public statement to be attached to their application confirming:

- 1. That they will comply with Public Performance Management Scheme, not as currently within 3 months of any decision, but in advance of the planning committee meeting.
- 2. That they have a commitment to be multicultural, multiethnic, inclusive, and promote equal opportunity projects. They should unambiguously confirm they are open to LGBT theatre and community projects, and to have no gender bias.
- 3. That there will be no censorship of performance or conference projects that can be scheduled within the building.

It is vitally important that for your remit to have meaning you should seek to preserve the spirit and heritage of this building as a widely accessible theatre space for the whole community.

Concerts, conferences, drama and dance festivals form the greater part of the 2007 permission. More limited was the use for worship on Sundays and Wednesdays only, with performances/entertainments during the rest of the week. Condition 3 of that permission required the maintenance of a strict schedule of performances. The proposed Islamic Cultural Centre use dramatically intensifies the 'religious' aspects of the building use to 7 days a week and for extended hours each day.

I have asked via Barnet Council for the applicant to clarify the extent of their commitment to the current planning condition:

'To hold concerts, conferences, drama and dance festivals.'

I look forward to hearing.

Clearly for condition 3 to have any real meaning the applicant must demonstrate that they have a commitment to be multicultural, multiethnic, promote equal opportunity projects, be open to LGBT theatre and community projects, and to have no gender bias etc. It is vitally important that for the statutory bodies remit to have meaning they should seek to preserve the spirt and heritage of this building as a widely accessible theatre space for the whole community. There should be an assurance (so far sadly lacking from the consultation process) that there will be no censorship of performance or conference projects that can be scheduled within the building under it's new ownership. Without a legally enforceable agreement there will be an inevitable loss of entertainments programming which would be a detrimental change for the building and locality.

We refer to the following official heritage guidance.

"Heritage Works", English Heritage's guidance document on the development of heritage buildings, states that:

"The best use for a building will often be the use for which it was originally designed and the continuation or reinstatement of that use may be the first option when the future of a building is considered." (emphasis added)

If the proposal is for use other than that for which the property was originally designed, paragraph 133 of the National Planning Policy Framework states that:

133. Where a proposed development will lead to substantial harm to or total loss of significance of a designated heritage asset, local planning authorities should refuse consent, unless it can be demonstrated that the substantial harm or loss is necessary to achieve substantial public benefits that outweigh that harm or loss, or all of the following apply:

the nature of the heritage asset prevents all reasonable uses of the site; and
 no viable use of the heritage asset itself can be found in the medium term through appropriate marketing that will enable its conservation; (emphasis added)

The DCLG's guidance note, "Conserving and Enhancing the Historic Environment", interprets Para 133 of the National Planning Policy Framework as follows: Appropriate marketing is required to demonstrate the redundancy of a heritage asset in the circumstances set out in paragraph 133, bullet 2 of the National Planning Policy Framework. The aim of such marketing is to reach all potential buyers who may be willing to find a use for the site that still provides for its conservation to some degree. If such a purchaser comes forward, there is no obligation to sell to them, but redundancy will not have been demonstrated. (emphasis added)

The current application is a watershed because it will be the first time that the Hippodrome has changed to a use without a substantial element of public performance.

Therefore, the Applicants should, as a minimum, be required to demonstrate the redundancy of this Grade II heritage asset, by carrying out an open marketing process, to see if anyone will purchase the building for public performance use.

We say that this guidance was written with properties like the Golders Green Hippodrome in mind. In view of the harm that the Current Proposal would do to the character of both the Conservation Area and the Grade II listed building, we think it is reasonable and essential that the Applicants carry out an appropriate marketing of the building.

Turning the the building's most recent sale earlier this year.

The building was sold by public auction. The suggestion by a local counsellor that the failure of a theatre company to successfully buy the building at auction, proves there is no viable theatre option.

I disagree with that assessment for the following reasons.

- 1. The auction process is a very truncated sales platform, it was not possible within the 6 week marketing period for interested theatre companies to deal with the necessary funding and due diligence required.
- 2. The 6 week marketing period was in the summer months.
- 3. The successful buyer at auction is a 'special purchaser' who bought in anticipation of having the current permission conditions varied. Consequently he overpaid, thus 'freezing' out genuine theatre groups.
- 4. The current owner has aspirations to turn the Golders Green Hippodrome into "one of Europes largest Islamic Cultural Centres". I would argue that that aspiration alone proves he was a 'special purchaser' and this was the driver behind their winning bid.
- A special purchase is described as a purchaser who has a special reason for acquiring an interest in a property eg whose special needs can be satisfied only by the acquisition of that interest in that particular property. The price which might reasonably be expected to be paid by a special purchaser will usually exceed that which might be paid by others in the open market.
- 5. The building was never adequately and fully marketed to theatre/entertainment/venue groups.

It is very unclear at the moment whether there have already been or will be any physical alterations. There is however a concern that the internal styling/decoration of the interior may in itself put off theatre producers, if the ambiance of the space is stridently Islamic.

There is real doubt about the extent of public access to what we would all regard as a truly open "concert, conference, drama, and dance festivals" venue.

It seems the statutory bodies set up to safeguard our heritage are either unable or unwilling to act. You are aware that the Public Performance Management Scheme is being ignored.

Barnet are similarly aware. Nothing is being done about it, that is a failure of our

institutions.

The intensification of use as possibly one of the largest Islamic Cultural Centres in Europe does not augur well for public theatrical space.

It is possible that I have misjudged or misunderstood the applicants commitment to public performance, theatre, and the liberal arts generally. Maybe they are ready, able, and willing to enthusiastically commit to the current conditions, and to accept the suggestions I have made above - perhaps you/Barnet would ask?

I am sure a producer could be asked to set out a performance programme, for consultation, to test both the viability of the venue in it's current format, and the commitment of the applicants to public theatrical space and all that entails.

At the very least you should strongly recommend to Barnet that to safeguard against any substantial loss of performances and entertainments at this Grade II Listed theatre, and to ensure an appropriate level of public performance for the benefit of the community, that the points I have made above are set out as a precondition of this application moving forward.

1. Congestion and Parking

The proposed mosque will measure 58,500ft and contain over 3000 seats. As such it will be one of the largest Islamic Centres in Europe. It would attract significant traffic from all over London and further afield. This would cause serious problems on what is already a busy major route and would further increase toxic emissions in an area where the legal limit for NO2 is already a problem in maintaining. This is an entirely inappropriate location for a place of worship of this size and nature. Parking is already a significant challenge for residents and this would make parking even more difficult.

I would like to object to the above New Planning Application on the following grounds:

1. Congestion and Parking

At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe.

Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen for such a development.

2. Golders Green and Hampstead Conservation Areas

The mosque will dominate the area and be completely out of character. It will be twice the size of Finsbury Park Mosque and comparable to Regents Park Mosque. The promoters have said they want it "To be among the largest Islamic Centres in Europe".

This beautiful Grade II listed building is an arts and performance space for all, not for just one part of the community. This application will get rid of concerts, conferences, drama and dance which will cater for all of the community.

If this building is allowed to be turned into a mosque it's will irreversibly and permanently change and even damage a unique centralised Golders Green landmark which has a great universal artistic heritage as well as a local character with amenities which would serve all of the community.

3. Disturbance

Residents reported constant disturbance until after midnight: car doors slamming, engines revving up and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The current owners and their community ignored these conditions, such as opening hours. This already shows that it would always be hard to enforce, e.g. during Ramadan and Muharram. The owners use of the Hippodrome already has broken planning control since 2017.

This is a clear indication that the change of use could not and would never be controlled by planning conditions. The problem would likely worsen if this planning permission were granted.
