- **Opening hours:** Use of the Hippodrome is currently restricted to 23:30 "to safeguard the amenities of occupiers of adjoining residential properties". The current owners have failed to observe this restriction to date and I am concerned they will do so in the future if the planning application is successful.
- Noise and disturbance: Existing conditions are set to "To safeguard the amenities of occupiers of adjoining residential properties" and "to safeguard the amenities of the area". Noise and disturbance increased considerably when the new owners started to use the building and there is clear evidence that things will get worse for residents as the usage increases if the planning application is successful. On certain days there were big celebrations with the influx of a huge number of people into the area. I believe the capacity of the building is 2000. This number of people coming into the residential and conservation area caused considerable problems. Some of the issues are identified below:
  - Large numbers of visitors (particularly compared to the numbers under the Hippodrome's previous occupiers, El-Shaddai Church) General background pedestrian and traffic noise;
  - · Aggressive and obstructionist parking;
  - Shouting in the street;
  - Blocking residential driveways;
  - Very loud music from Car stereo's being played even late at night and long passed 11.30pm;
  - Hooting by blocked drivers, including ambulances;
  - Aggressive behaviour or "road rage" by drivers who are angry they cannot pass or park in neighbouring roads;
  - Noise from visitors leaving the building and going to their vehicles after midnight in previously quiet residential streets;
  - · Hindrance to public transport; and
  - Hindrance to emergency services, increasing risk to local residents' lives.
  - Huge increase in rubbish thrown onto the streets around the building, in surrounding street and from the cars.

**Congestion and Parking:** Traffic problems I have noted by the Applicants' use of the Hippodrome to date are:

- Severe restriction of two-way movement along streets, due to cars being parked along the full length of both sides of the road and in some cases causing grid lock;
- Blocked or partially blocked driveways, even where there are drop down curbs making access to and from residential homes impossible. Please see the photographs attached;
- Cars parked on double yellow lines up to the corner of West Heath Avenue and West Heath Drive, creating road safety hazards at the junction of North End Road, please see the attached photographs;
- Cars parked on double yellow lines near Golders Hill Park, a vulnerable corner for local children but also blocking access to and from Golders Park Close, a Cul de Sac so you cannot leave or return to the Cul de Sac as the traffic is grid locked;
- Grid lock occurring at the bottom end of West Heath Drive near the park entrance as there is a sharp 90 degree bend and so visibility around the corner form either direction is impossible. Cars are unable to pass around

- the corner due to parked cars and there is no space to pull over to permit anyone to pass;
- Traffic conflicts. Cars parked repeatedly on pavements force pedestrians to
  walk in the road if they are able around all of the traffic in the road. It is
  extremely dangerous for all pedestrians including the visitors who often
  have young children with them even late at night; and
- Pollution caused by increased traffic flows and in particular stationary cars in the grid lock that is created.

Artistic heritage: I understand the planning application includes the owners to use the Hippodrome for concerts, drama and dance festivals. Such events would be incompatible with use of the property as intended currently and effectively would mean only a small percentage of the local residents would be able to avail themselves of the facilities. So the buildings use would be predominantly for people who live throughout London and further afield and it would no longer be an amenity for the local community.

As evidence to support my objection to the application by the owners of the Hippodrome I am attaching photographs of illegally parked cars in and around the surrounding roads on an evening when the Hippodrome was used last year. But as a comparison I have also enclosed photographs of the roads on other nights when the Hippodrome was not being used. You will see the stark contrast and how disruptive the influx of lots of people has on the area. The studies commissioned have not taken this into account as they are subjective and based on statistical data and in my opinion do not show the reality of what occurs.

I also when i was trying to turn into my street, got hailed down by young men with high viz jackets on asking where I was going. I appreciate they were trying to improve the madness of the parking but they had no authority and made me feel very vunerable.

The noise levels of allowing the biggest mosque in Europe to be allowed to open until late in the night would be truly unbearable for the largely residential area.

I am aware that they have said that people will use public transport, but this has certainly not been our experience when it was open and indeed how can they use public transport after midnight for that many people .

I truly feel to place a huge mosque in the middle of a resdiential area which would be allowed to be used late at night with the noise and parking implications would be catastrophic.


Here are some of my points to explain my protest.

I am writing to you to raise my strong objection to the new application to turn Golders Green Hippodrome to turn it into a mosque. This new application shouldn't be a way for the Council and the Hippodrome owners to get out of the existing Appeal due to be heard soon. This application seems to be a controversial move and the Council should refuse it so that it can be joined with the current Appeal, to be settled by the planning inspector.

Application reference number: 20/2988/FUL

Site Address: Golders Green Hippodrome, London NW11 7RP.

Below are my points due which I object to the conversion of Golden Green Hippodrome into a mosque.

## 1. Golders Green and Hampstead Conservation Areas:

The mosque will dominate the area and be completely out of character. It will be twice the size of Finsbury Park Mosque and comparable to Regents Park Mosque. The promoters have said they want it "To be among the largest Islamic Centres in Europe". This beloved Grade II listed building is an arts and performance space for all, not for just one part of the community. The application will get rid of concerts, conferences, drama and dance. It will irreversibly harm the building's artistic heritage, local character and people's amenities.

## 2. Congestion and Parking:

At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.

## 3. Disturbance:

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions. The problem would likely worsen if this planning permission went through.

Hope you will take notice of this and take necessary action and steps towards this objection. Thanks!


