I am writing to submit my comments against the development of the hippodrome into a place of worship on the following grounds:

- 1. Scale: Golders Green has a high concentration of all religions and people. They pray in many small churches, temples and synagogues across the area. Small crowds are less likely to create problems than big crowds. My concern is that the Hippodrome is so massive that it will become an imposing, maybe even scary location. Wouldn t it make more sense to have 3 or 4 smaller mosques built in the area to reduce this local intimidation? Golders Green is a very multicultural area with so many cultures and religions co-existing. There is a risk that a huge mosque risks alienating a harmonious heterogenous local population and damaging the local culture.
- 2. **Traffic congestion:** this would introduce an enormous number of extra cars to the already congested area.
- 3. **Parking difficulties:** There are currently so few parking spaces available if one wants to visit one of the local shops. With so many more cars on the road, this parking would become even more challenging.

Good afternoon,

I hope you are all well and staying safe.

I refer to the Planning Application mentioned in the Subject space.

The Jewish Community in the UK is a very small one, and there are very few areas in the whole country with a high concentration of Jews. One of the highest if not the highest is Golders Green. 

I strongly object to this application for the following reasons:

1. <u>Harm to the Golders Green and Hampstead conservation area and local</u> <u>residents</u>

The proposed mosque is absurdly massive in size and in total disrespect for its surroundings. It is arrogant in its design and appearance, has nothing in common with its surroundings, imposes on the neighbouring conservation character and simply projects a force of domination onto the local community. Its size is totally out of proportion and preponderant : it will be twice the size of Finsbury Park mosque and comparable to the biggest mosque in London. Stating its ambition to become "one of the largest Islamic centres in Europe", is absurd, taken out of context, and demonstrates it will not serve its local community but reach far and beyond. It will bring irreversibly harm to the building's artistic heritage, local character, and people's amenities.

2. Loss of a grade 2 listed building, which served a LOCAL community, offering a wide array of services across all ages.

This is an arts and performance building that is currently used for a wide and diverse community, benefiting all ages, all races, and all faiths (instead of 1 faith). It is a real shame that so many youths of different faiths will no longer be able to come together and use its many benefits. The proposed application provides no substitution for the many services now offered such as concerts, conferences, drama and dance.

3. Unacceptable increase in congestion and parking issues.

I believed Barnet had a duty to provide development that discourages cars and allows for a reduction in carbon footprint. Given the proposed ambition and its resulting size, it is clear this venue will attract people from far and beyond, from across North London, even the UK and Europe.

Its proposed opening hours to 23:30 implies a large percentage of the people attending will resort to cars as a means of transportation.

Congestion is already ridiculous on this major road, and it would become simply untenable across the week, but especially on religious days. This area exceeds already 2-times the legal limit for NO2. The carbon footprint would increase dramatically.

There is simply not enough parking, parking on yellow lines is already a massive, continuous problem. As you know, local residents have repeatedly voiced concerns over the years, and will suffer even more from illegal parking and

obstruction this proposed will cause because of the thousands of people it will attract.

4. Serious harm to amenity for local residents

Why should the proposed be allowed to serve far and beyond its community if, when doing so, it will harm the amenity of its local residents? Often the increase in harm inflicted by a building is exponential (ie not linear) to its increase in size. Why does this development need to serve beyond its local community, if only a very small percentage of its local community will be able to benefit from it, but instead, a massive percentage of its local residents will suffer harm to their amenity?

This is simply unacceptable.

Local resident's amenity will be severely harmed because of the massive increase in footfall as well as an increase in the use of cars because of the proposed, and this at all times of the day.

The current hippodrome is already causing residents massive disturbance, such as fracas well after midnight of car doors slamming, engines revving and lack of consideration for people asleep. This will become exponential because of the ridiculous size and amount of people the proposed aims to attract.

Comment: I am writing to object to this proposal on the basis that an increase in the number of visitors to the Hippodrome compared to its previous occupiers, will create substantially more pedestrian and traffic congestion and noise.

The increase in numbers of people and vehicles in the surrounding area will lead to a rise in inconsiderate parking, blocking residents driveways and an increase in noise at unsociable hours.

There will be an increase in the noise from people visiting the mosque after midnight - waking residents who have a reasonable expectation for their peace and quiet not to be disturbed in the early hours of the morning. There will be an increase in the amount of people sitting in their cars playing loud music and chatting loudly along the road. No consideration is made for the lateness of the hour, or for people sleeping.

Congestion to Rotherwick Road, with vehicles being parked on both sides of the street, does not allow free movement of two vehicles along the road, which is dangerous to pedestrians and cars and causes massive congestion.

A car trying to enter Rotherwick Road from the Finchley Road cannot safely do so with cars parked on both sides of the road. There are no weekend parking restrictions on Rotherwick Road, despite its proximity to the Hippodrome and lack of observance of the double yellow lines on both sides of the road has been a persistent problem on days and at times when the mosque is in use. Comment: I am writing to object to the new planning proposals to the Hippodrome on the following grounds. I live in a road that is near the Hippodrome and is impacted by its use.

Most notably we have found that congestion and parking in our road is significantly worse on days and at times when the mosque is in use, being its worst at the weekends.

Significant traffic problems are caused by people using the mosque parking in our road, on both sides of the street, and often very inconsiderately. We have had our driveway blocked on a number of occasions, meaning that there is no way to get our car out of our driveway, once when we needed to take our son to hospital. There is no accountability and no way to deal with inconsiderate drivers, who often return to their cars late at night, after we have gone to sleep. At other times they sit in their cars, with music playing loudly, causing noise disturbance.

When cars are parked the whole way up and down the road, it does not allow two way traffic to pass down the road, which is dangerous. There is no where to pull in and leads to significant traffic jams. The increase in cars congested on the road increases pollution levels, which raises the emissions to dangerously toxic levels.

No parking restrictions in this road, which is in very close proximity to the Hippodrome make living in the road miserable at the times the mosque is in use. The inability to park inside our own driveway, or indeed across our own driveway, makes going out in the car at the weekend almost impossible. It has a material impact on our enjoyment of our own house on the road.

We have 4 children and spend a lot of time taking and collecting them at the weekend from

various activities. The increase in vehicles due to visitors to the mosque make this a real challenge and have caused us to want to move at times. Inconsiderate parking, noise at late hours, loud music played late in to the night materially affects our enjoyment of our road/house.

I am writing to you to raise my strong objection to the new application to turn Golders Green Hippodrome to turn it into a mosque. This new application shouldn't be a way for the Council and the Hippodrome owners to get out of the existing Appeal due to be heard soon. This application seems to be a controversial move and the Council should refuse it so that it can be joined with the current Appeal, to be settled by the planning inspector.

Application reference number: 20/2988/FUL Site Address: Golders Green Hippodrome, London NW11 7RP.

Below are my points due which I object to the conversion of Golden Green Hippodrome into a mosque.

1. Golders Green and Hampstead Conservation Areas:

The mosque will dominate the area and be completely out of character. It will be twice the size of Finsbury Park Mosque and comparable to Regents Park Mosque. The promoters have said they want it "To be among the largest Islamic Centres in Europe". This beloved Grade II listed building is an arts and performance space for all, not for just one part of the community. The application will get rid of concerts, conferences, drama and dance. It will irreversibly harm the building's artistic heritage, local character and people's amenities.

2. Congestion and Parking:

At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.

3. Disturbance:

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions. The problem would likely worsen if this planning permission went through.

Hope you will take notice of this and take necessary action and steps towards this objection. Thanks!
