Golders Green broadcaster and oral historian Alan Dein believes this is a key opportunity for the Hippodrome to fulfil its potential and become a "significant arts and cultural complex" once again.




I am outraged at the proposal to build a place of worship in Golders Green and Hampstead Conservation area. There are three issues of concern;

Firstly the site is a grade 2 listed property intentioned for all our community to enjoy concerts and the arts for the entire community not a place of worship for one faith excluding all others.

I would like to submit my opposition to the application for the Golders Green Hippodrome, North End Road, London NW11 7RP to be used as a place of worship.

Prior to Covid (within the last 2 years), the Hippodrome was used as a community centre and at the time of a religious festival this caused an excessive amount of traffic and associated pollution throughout the surrounding roads. As a resident (NW11 this made it increasingly challenging to come in and out of my own driveway at any time of day but especially in the evenings when non-residents parking is allowed on the street. If planning was approved for this conversion to a place of workshop this would become a regular occurrence causing a significant amount of stress and frustration from all home owners in the surrounding streets. Given the already extensive parking restrictions on West Heath Drive it would also become challenging for any of the resident's visitors to be able to find a space on the road.

The corner of North End Road and West Heath Drive is already congested with many cars illegally parking for short periods of time to visit nearby shops. With additional volume of traffic in such close proximity to a nursery (located within the Church on West Heath Drive) this would make the road unbearably congested with traffic, increase the air pollution to possibly dangerous levels and be a significant hazard to the children and parents attending the nursery.

I also understand that a previous application for the same address to be converted to a synagogue was rejected so hope that for all the same reasons, this application will also be rejected.




I am pleased that a Barnet building with such historic and physical prominence is once again being used and I have already visited the community there and been shown around. I look forward to many more interfaith activities.

It will attract hundreds of people at all hours, with official hours to 23.30.

The noise of people and cars trying to park and slamming car doors at all hours will make it difficult for the local residents.

My worries are that instead of creating something that can be used for social and educational purposes for the local community youth and adult services, you are bringing into the area thousands of people many of whom will come by car and the local infrastructure is already struggling with parking facilities.

The mosque that you are planning to build is huge and out of proportion to the surrounding area. Cars would come from all around including the UK and Europe. The congestion would be dangerous due to the increased emissions which would result. We are already suffering with high toxic levels. This would increase the problem having health repercussions for all the residents.

I object to planning permission being granted for the reason that my husband is a blue badge holder, and when I take him to hospital appointments or chiropodist or dental appointments , even to go to the post office , bank etc there is already congestion and limited parking in the vicinity of the hippodrome , underground, bus station and shopping amenities .

This is a major route - and this planning application is simply unthinkable

In addition, toxic emissions would affect breathing in this area. The U.K. government is planning to reduce emissions.

Promises to manage traffic have failed. Events advertise 'Free parking available along North End Road' or simply 'Car park'. Public transport details are not provided. Coupled with late opening hours, this encourages people to come by car. 30 parking spaces are inadequate making traffic and congestion unmanageable at this sensitive, central location,

increasing the already twice the legal limit for NO2 toxic emissions levels.

Traffic congestion and parking on yellow lines have been continuous.

Residents' lives have been badly affected by illegal parking and congestion. One local resident reported an 8-minute wait to turn into their street, only to find their driveway parked on. This is the worst location that the Appellants could have chosen for a mega mosque.

Disturbance

Residents report constant disturbance until after midnight: car doors slamming, engines revving, visitors lacking consideration for people sleeping. A planning condition imposed on the building in 2007 was for this very reason: 'to safeguard the amenities of the area'. Opening hours and other conditions have been ignored. The owners have already shown that use of the Hippodrome as a mosque could not be contained by planning conditions.

Detailed Planning Considerations

The loss of this building listed as "a rare example of a surviving suburban theatre, largely intact", for public theatre use is truly worrying.

The Hippodrome was built by renowned theatre architect Bertie Crewe in 1913 as a 3,000-seater musical venue.

It has staged performances and live concerts by legends including Danny La Rue and Marlene Dietrich.

Golders Green broadcaster and oral historian Alan Dein believes this is a key opportunity for the Hippodrome to fulfil its potential and become a "significant arts and cultural complex" once again.

Mr Dein described how after the Hippodrome was built in 1913, it "served up an incredible range of pre and post West End shows, opera, musicals, pantomimes, jazz bands, ballet and even Rock and Roll".

Mr Dein added: "The likes of Radio 2's 'Friday Night is Music Night' broadcast to the whole nation became part of Golders Green legend!"

The Hippodrome was sold to the evangelical El Shaddai International Christian Centre in 2007 they received permission to use the building as a church, subject to conditions.

Condition 3 of the 2007 planning permission positively required that the Hippodrome hold a large number of performances and entertainments each week and month. These were set out at page 6 of the 2007 Planning Officer's Report, as including:

Weekly (either once a week or every day depending on activity)

- dance classes for children and youth; 3. drama groups;
- instrument tuition;
- single tuition;
- · children's and youth choir;

Special Events (Held Approx once a month)

- · Music concerts with visiting musicians;
- Pantomimes;
- drama performances held for children, including puppet shows, visiting theatrical groups etc.

There will also be activities for adults. These include Monthly

- Concerts by visiting musicians/bands and orchestras;
- Theatrical performances (how inclusive, diverse, open and transparent bearing in mind Islamic traditions are not always comparable with western values)

Condition 3 states:

3. The applicants shall submit a public performance management scheme to be submitted to and approved in writing by the Local Planning Authority within three months of the date of this decision. The use and associated public performance activities shall be carried out strictly in accordance with the approved scheme.

Reason: To ensure an appropriate level of public performance for the benefit of the community.

Currently the above Condition is being flouted by the new owners of the building. The previous owners, the El Shaddai International Christian Centre also failed to follow the Public Performance Management Scheme. I fail to see how, if Barnet fail to enforce the current conditions that there can be any confidence that they will do so once the building is more intensively used, as is now proposed. Accordingly there has been and will be a substantial loss of performances and entertainments at this Grade II Listed theatre that forms the heart of this Conservation Area.

Like it or not this new Application is a turning point because it will be the first time that the Hippodrome will change to a use without a substantial element of public performance. It is naive to think that since Condition 3 (above) of the 2007 permission has continually been ignored, that a liberalisation of the conditions (which is effectively what is now being proposed) will be enforced or enforceable by Barnet - they have shown little appetite for enforcement (unless forced by local public pressure) on this condition in the past.

It would be very straight forward for Historic England/Barnet to simply require the Applicant to produce a proper public statement clarifying their view of say LGBT+ theatre generally.

- 1. That they will comply with Public Performance Management Scheme, not as currently within 3 months of any decision, but in advance of the planning committee meeting.
- 2. That they have a commitment to be multicultural, multiethnic, inclusive, and promote equal opportunity projects. They should unambiguously confirm they are open to LGBT+ theatre and community projects, and to have no gender bias.
- 3. That there will be no censorship of performance or conference projects that can be scheduled within the building.

It is vitally important that for your remit to have meaning you should seek to preserve the spirit and heritage of this building as a widely accessible theatre space for the whole community.

Concerts, conferences, drama and dance festivals form the greater part of the 2007 permission. More limited was the use for worship on Sundays and Wednesdays only, with performances/entertainments during the rest of the week. Condition 3 of that permission required the maintenance of a strict schedule of performances. The proposed Islamic Cultural Centre use dramatically intensifies the 'religious' aspects of the building use to 7 days a week and for extended hours each day.

The Applicant must unambiguously clarify the extent of their commitment to the current planning conditions:

'To hold concerts, conferences, drama and dance festivals.'

Clearly for condition 3 to have any real meaning the applicant must demonstrate that they have a commitment to be multicultural, multiethnic, promote equal opportunity projects, be open to LGBT+ theatre and community projects, and to have no gender bias etc. It is vitally important that for the statutory bodies remit to have meaning they should seek to preserve the spirit and heritage of this building as a widely accessible theatre space for the whole community. There should be an assurance (so far sadly lacking from the consultation process) that there will be no censorship of performance or conference projects that can be scheduled within the building under Markaz El Tathgheef El Eslami's ownership. Without a legally enforceable agreement there will be an inevitable loss of entertainments programming which would be a detrimental change for the building and locality.

I refer to the following official heritage guidance.

"Heritage Works", English Heritage's guidance document on the development of heritage buildings, states that:

"The best use for a building will often be the use for which it was originally designed and the continuation or reinstatement of that use may be the first option when the future of a building is considered." (emphasis added)

If the proposal is for use other than that for which the property was originally designed, paragraph 133 of the National Planning Policy Framework states that:

133. Where a proposed development will lead to substantial harm to or total loss of significance of a designated heritage asset, local planning authorities should refuse consent, unless it can be demonstrated that the substantial harm or loss is necessary to achieve substantial public benefits that outweigh that harm or loss, or all of the following apply:

- the nature of the heritage asset prevents all reasonable uses of the site; and
- on viable use of the heritage asset itself can be found in the medium term through appropriate marketing that will enable its conservation; (emphasis added)

The DCLG's guidance note, "Conserving and Enhancing the Historic Environment", interprets Para 133 of the National Planning Policy Framework as follows:

Appropriate marketing is required to demonstrate the redundancy of a heritage asset in the circumstances set out in paragraph 133, bullet 2 of the National Planning Policy Framework. The aim of such marketing is to reach all potential buyers who may be willing to find a use for the site that still provides for its conservation to some degree. If such a purchaser comes forward, there is no obligation to sell to them, but redundancy will not have been demonstrated. (emphasis added)

The current application is a watershed because it will be the first time that the Hippodrome has changed to a use without a substantial element of public performance. Therefore, the Applicants should, as a minimum, be required to demonstrate the redundancy of this Grade II heritage asset, by carrying out an open marketing process, to see if anyone will purchase the building for public performance use.

The guidance was written with properties like the Golders Green Hippodrome in mind. In view of the harm that the Current Proposal would do to the character of both the Conservation Area and the Grade II listed building, it is reasonable and essential that the Applicants carry out an appropriate marketing of the building.

- 1. This is a cynical attempt to circumvent the planning process. The current Inquiry is the legitimate and natural next step in the process which has been delayed since 2017.
- 2. Theatrical Use. I have referred at length to the importance of the Golders Green Hippodrome above. The new Application, while 'ticking all the right boxes' and very professionally prepared offers nothing in the way of what the average person would consider a true theatre experience, it is neither diverse nor inclusive, but a distracting 'wish' list of 'worthy' sound bites. Had the Applicant truly wanted to demonstrate his desire to honour the current Planning Consent (all of which he was aware of before he purchased the building), he could have at any time done so. The Applicant's passed conduct is both informative and very likely a strong indicator of his likely predisposition of non-compliance in the future realistically how easy will it be for the Applicant to dilute or simply ignore the Public Performance Management Scheme.
- 3. Transport. The Transport Assessment and Travel Plans are again 'professionally' prepared and at first sight persuasive, they are however misleading and disingenuous. There is no significant Islamic population sufficient to fill the Applicant's aspiration to create one of the largest Mosques in Europe within easy travel distance. Many of the congregation will have to travel far, however the Travel Plan misses a fundamental but perhaps unspoken truth that many of the regular congregation are car users. I think it a fair observation and perhaps a generalisation (but nonetheless true) that a significant percentage of mini cab/Uber drivers follow the islamic faith. This is not surprising as the flexible work hours allow drivers to fully follow their religion and prayer times. The consequence of this is (as at the Regent's Park Mosque) haphazard parking throughout the day, becoming chaotic on high days and holidays. If this Application is permitted I would expect parking control to be swamped by both illegally parked and inconsiderately parked vehicles throughout the day.
- 4. The Transport Assessment & Travel Plans in detail: 2.8 "Development should only be prevented or refused on highways grounds if there would be an unacceptable impact on highway safety, or the residual cumulative impacts on the road network would be severe." Clearly if this development were to go ahead there would be a severe impact on the local highways. 2.15 The 'check list' of supposed contributions the development would make is merely a generic 'wish list' lacking any verification or authentication. The tables set out under 5.0 Trip Generation are selective, dubious and misleading. As an example anticipated vehicle visits are on the face of it over 50% with less than 5% arriving by bus, tram and rail. Experience tells us, the local residents that the vehicle arrivals are well in excess of the anticipated number.

The general thrust of the Motion document clearly recognises that there would be a highway problem should the development be permitted and tries to head that off by getting their retaliation in first. Motion then provide 50 pages of bogus precision and elastic formulae to try to mitigate the 'problem' of the Applicants making should the development be permitted. It would be better by far if the Application is rejected and the current inquiry proceed.

All of the above can adequately be determined at the public inquiry.

This opportunistic Application and it's various attachments are nothing more than calculated and meticulously presented shenanigans.

Golders Green broadcaster and oral historian Alan Dein believes this is a key opportunity for the Hippodrome to fulfil its potential and become a "significant arts and cultural complex" once again.

Mr Dein described how after the Hippodrome was built in 1913, it "served up an incredible range of pre and post West End shows, opera, musicals, pantomimes, jazz bands, ballet and even Rock and Roll".

Mr Dein added: "The likes of Radio 2's 'Friday Night is Music Night' broadcast to the whole nation became part of Golders Green legend!"

The Hippodrome was sold to the evangelical El Shaddai International Christian Centre in 2007 they received permission to use the building as a church, subject to conditions.

Condition 3 of the 2007 planning permission positively required that the Hippodrome hold a large number of performances and entertainments each week and month. These were set out at page 6 of the 2007 Planning Officer's Report, as including:

Weekly (either once a week or every day depending on activity)

- · dance classes for children and youth; 3. drama groups;
- · instrument tuition;
- · single tuition;
- · children's and youth choir;

Special Events (Held Approx once a month)

- · Music concerts with visiting musicians;
- · Pantomimes;
- drama performances held for children, including puppet shows, visiting theatrical groups etc.

There will also be activities for adults. These include Monthly

- · Concerts by visiting musicians/bands and orchestras;
- Theatrical performances (how inclusive, diverse, open and transparent bearing in mind Islamic traditions are not always comparable with western values)

Condition 3 states:

3. The applicants shall submit a public performance management scheme to be submitted to and approved in writing by the Local Planning Authority within three months of the date of this decision. The use and associated public performance activities shall be carried out strictly in accordance with the approved scheme.

Reason: To ensure an appropriate level of public performance for the benefit of the community.

Currently the above Condition is being flouted by the new owners of the building. The previous owners, the El Shaddai International Christian Centre also failed to follow the Public Performance Management Scheme. I fail to see how, if Barnet fail to enforce the current conditions that there can be any confidence that they will do so once the building is more

intensively used, as is now proposed. Accordingly there has been and will be a substantial loss of performances and entertainments at this Grade II Listed theatre that forms the heart of this Conservation Area.

Like it or not this new Application is a turning point because it will be the first time that the Hippodrome will change to a use without a substantial element of public performance. It is naive to think that since Condition 3 (above) of the 2007 permission has continually been ignored, that a liberalisation of the conditions (which is effectively what is now being proposed) will be enforced or enforceable by Barnet - they have shown little appetite for enforcement (unless forced by local public pressure) on this condition in the past.

It would be very straight forward for Historic England/Barnet to simply require the Applicant to produce a proper public statement clarifying their view of say LGBT+ theatre generally.

- 1. That they will comply with Public Performance Management Scheme, not as currently within 3 months of any decision, but in advance of the planning committee meeting.
- 2. That they have a commitment to be multicultural, multiethnic, inclusive, and promote equal opportunity projects. They should unambiguously confirm they are open to LGBT+ theatre and community projects, and to have no gender bias.
- 3. That there will be no censorship of performance or conference projects that can be scheduled within the building.

It is vitally important that for your remit to have meaning you should seek to preserve the spirit and heritage of this building as a widely accessible theatre space for the whole community.

Concerts, conferences, drama and dance festivals form the greater part of the 2007 permission. More limited was the use for worship on Sundays and Wednesdays only, with performances/entertainments during the rest of the week. Condition 3 of that permission required the maintenance of a strict schedule of performances. The proposed Islamic Cultural Centre use dramatically intensifies the 'religious' aspects of the building use to 7 days a week and for extended hours each day.

The Applicant must unambiguously clarify the extent of their commitment to the current planning conditions:

"To hold concerts, conferences, drama and dance festivals."

Clearly for condition 3 to have any real meaning the applicant must demonstrate that they have a commitment to be multicultural, multiethnic, promote equal opportunity projects, be open to LGBT+ theatre and community projects, and to have no gender bias etc. It is vitally important that for the statutory bodies remit to have meaning they should seek to preserve the spirit and heritage of this building as a widely accessible theatre space for the whole community. There should be an assurance (so far sadly lacking from the consultation process) that there will be no censorship of performance or conference projects that can be scheduled within the building under Markaz El Tathgheef El Eslami's ownership. Without a legally enforceable agreement there will be an inevitable loss of entertainments programming which would be a detrimental change for the building and locality.

I refer to the following official heritage guidance.

"Heritage Works", English Heritage's guidance document on the development of heritage buildings, states that:

"The best use for a building will often be the use for which it was originally designed and the continuation or reinstatement of that use may be the first option when the future of a building is considered." (emphasis added)

If the proposal is for use other than that for which the property was originally designed, paragraph 133 of the National Planning Policy Framework states that:

133. Where a proposed development will lead to substantial harm to or total loss of significance of a designated heritage asset, local planning authorities should refuse consent, unless it can be demonstrated that the substantial harm or loss is necessary to achieve substantial public benefits that outweigh that harm or loss, or all of the following apply:

- the nature of the heritage asset prevents all reasonable uses of the site; and
- no viable use of the heritage asset itself can be found in the medium term through appropriate marketing that will enable its conservation; (emphasis added)

The DCLG's guidance note, "Conserving and Enhancing the Historic Environment", interprets Para 133 of the National Planning Policy Framework as follows:

Appropriate marketing is required to demonstrate the redundancy of a heritage asset in the circumstances set out in paragraph 133, bullet 2 of the National Planning Policy Framework. The aim of such marketing is to reach all potential buyers who may be willing to find a use for the site that still provides for its conservation to some degree. If such a purchaser comes forward, there is no obligation to sell to them, but redundancy will not have been demonstrated. (emphasis added)

The current application is a watershed because it will be the first time that the Hippodrome has changed to a use without a substantial element of public performance. Therefore, the Applicants should, as a minimum, be required to demonstrate the redundancy of this Grade II heritage asset, by carrying out an open marketing process, to see if anyone will purchase the building for public performance use.

The guidance was written with properties like the Golders Green Hippodrome in mind. In view of the harm that the Current Proposal would do to the character of both the Conservation Area and the Grade II listed building, it is reasonable and essential that the Applicants carry out an appropriate marketing of the building.

- 1. This is a cynical attempt to circumvent the planning process. The current Inquiry is the legitimate and natural next step in the process which has been delayed since 2017.
- 2. Theatrical Use. I have referred at length to the importance of the Golders Green Hippodrome above. The new Application, while 'ticking all the right boxes' and very professionally prepared offers nothing in the way of what the average person would consider a true theatre experience, it is neither diverse nor inclusive, but a distracting 'wish' list of 'worthy' sound bites. Had the Applicant truly wanted to demonstrate his desire to honour the current Planning Consent (all of which he was aware of before he purchased the building), he could have at any time done so. The Applicant's passed conduct is both informative and very likely a strong indicator of his likely predisposition of non-compliance in the future realistically how easy will it be for the Applicant to dilute or simply ignore the Public Performance Management Scheme.
- 3. Transport. The Transport Assessment and Travel Plans are again 'professionally' prepared and at first sight persuasive, they are however misleading and disingenuous. There is no significant Islamic population sufficient to fill the Applicant's aspiration to create one of the largest Mosques in Europe within easy travel distance. Many of the congregation will have to travel far, however

the Travel Plan misses a fundamental but perhaps unspoken truth that many of the regular congregation are car users. I think it a fair observation and perhaps a generalisation (but nonetheless true) that a significant percentage of mini cab/Uber drivers follow the islamic faith. This is not surprising as the flexible work hours allow drivers to fully follow their religion and prayer times. The consequence of this is (as at the Regent's Park Mosque) haphazard parking throughout the day, becoming chaotic on high days and holidays. If this Application is permitted I would expect parking control to be swamped by both illegally parked and inconsiderately parked vehicles throughout the day.


4. The Transport Assessment & Travel Plans in detail: 2.8 "Development should only be prevented or refused on highways grounds if there would be an unacceptable impact on highway safety, or the residual cumulative impacts on the road network would be severe." - Clearly if this development were to go ahead there would be a severe impact on the local highways. 2.15 The 'check list' of supposed contributions the development would make is merely a generic 'wish list' lacking any verification or authentication. The tables set out under 5.0 Trip Generation are selective, dubious and misleading. As an example anticipated vehicle visits are on the face of it over 50% with less than 5% arriving by bus, tram and rail. Experience tells us, the local residents that the vehicle arrivals are well in excess of the anticipated number.

The general thrust of the Motion document clearly recognises that there would be a highway problem should the development be permitted and tries to head that off by getting their retaliation in first. Motion then provide 50 pages of bogus precision and elastic formulae to try to mitigate the 'problem' of the Applicants making should the development be permitted. It would be better by far if the Application is rejected and the current inquiry proceed.

All of the above can adequately be determined at the public inquiry.

This opportunistic Application and it's various attachments are nothing more than calculated and meticulously presented shenanigans.

It seems to be Markaz El Tathgheef El Eslami's aim that consent will aid cross cultural harmony, however this Application being so vigorously opposed by the resident community is far more likely to spread distrust and rancour if consented. Especially so since the Planning 'games' and manoeuvres (this Application) being adopted are so unfair, unnecessary and motivated purely by self-interest.





1. Golders Green and Hampstead Conservation Areas

The mosque will dominate the area and be completely out of character. It will be twice the size of Finsbury Park Mosque and comparable to Regents Park Mosque. The promoters have said they want it "To be among the largest Islamic Centres in Europe".

This beloved Grade II listed building is an arts and performance space for all, not for just one part of the community. The application will get rid of concerts, conferences, drama and dance. It will irreversibly harm the building's artistic heritage, local character and people's amenities.



2. Congestion and Parking

At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.



3. Disturbance

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions. The problem would likely worsen if this planning permission went through.

I felt scared and intimidated(the center is now temporarily closed due to Covid 19), and I shouldn't feel that way.



At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.


3. Disturbance:

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. At over 58,500 sq feet, and over 3000 seats, plus standing room, one of the "largest Islamic Centres in Europe" would attract cars from across the UK and Europe. Opening hours to 23.30 would force people to drive home. Traffic congestion and parking on yellow lines have been continuous problems, and residents' lives have been badly affected by illegal parking and obstruction. Promises to manage traffic completely failed. Congestion is already serious on this major route, and it would become impossible. This mosque would intensify toxic emissions, where twice the legal limit for NO2 has already been reached. This is the worst place the applicants could have chosen.

3. Disturbance

Residents reported constant disturbance until after midnight: car doors slamming, engines revving, and lack of consideration for people asleep. Planning conditions were imposed in 2007 for this reason: "to safeguard the amenities of the area". The mosque ignored these conditions, such as opening hours, which would always be hard to enforce, e.g. during Ramadan and Muharram. Their use of the Hippodrome has broken planning control since 2017, and indicates that the use could not be controlled by planning conditions. The problem would likely worsen if this planning permission went through.

Hope you will take notice of this and take necessary action and steps towards this objection. Thanks!
