Comment:I strongly object to a change of use to a place of worship. Without other provision in place, West Heath Drive ("WHD") and the surrounding streets will become the de facto car park for the Hippodrome. From what we've seen when the centre was last opened, prior to the current restrictions being put in place, that's not a workable arrangement. It had a severe negative impact and caused an incredible amount of disruption to the area, with the increased traffic, congestion, noise, littering, disruption to the normal working of public transport, intimidating groups of young men hanging around, parking on driveways, blocking of driveways and parking on single and double yellow lines. The area is already congested with parked cars and traffic on WHD and the surrounding streets.

Apart from parking or related issues, to have such crowds and potential noise as was the case previously when the centre was open is not in my belief, conducive to a mainly residential area of Golders Green and certainly in my case, will not help my kids to get the sleep they need during school days.

Also, part of the issue with the new centre becoming a place of "worship" is that the influx of people from outside the local area would not be limited to one time of day or one day a week. The mosque would no doubt be running services and large events throughout the week, meaning the impact is ongoing, not just on Sundays or at particular times like it was for its previous use as a "church". The change of use proposed has wide implications that needs a much bigger consultation, thought and restrictions to be put in place to protect local residents from the huge extra number of cars that result. When the centre was a Christian church, the attendees of that church were of a much smaller number and were always considerate to the local area and residents. Also, the church was only used at limited times.

This new centre has already proven that a potential change to the use of the building is massively detrimental; that attendee numbers vastly increased; and that those attendees are completely inconsiderate of their impact to the local area. The use of the building as a mosque has already created a completely different and more disruptive pattern of use. This is not about the faith that is being practised at the Hippodrome, its about the fact that the congregation have already proved that they are incapable of being considerate toward the local community, and the management of the building are unable to mitigate the deterioration of the quality of life of the residents of this once charming and tranquil neighbourhood.

- There would be a significant burden of many thousands of prospective additional people on the traffic circulation and public transport amenities in the area.

- There would be a significant adverse impact of additional vehicles upon pollution and the green credentials of Golders Green, making the air less clean for children and adults alike on a road which is already twice the legal limit for nitrous dioxides.

- There would be a material increase to the risk of road traffic accidents, on a narrow road with 4 schools, due to heavier circulation. Traffic congestion and conflicting vehicle movements would cause unacceptable potential danger to residents and users of local streets.

- There would be an increased burden of several hundred parking spaces on an already-strained North End Road.

Comment:During times of high-occupancy services at the Hippodrome since 2017, the entire area was grid-locked with cars parked on double yellow lines, close to road junctions and across driveways. The undertaking to provide on-street wardens to control this vehicular influx, however well intentioned, failed as there is nowhere to send the cars once they are caught in the cross-roads logjam. There are no parking facilities in the area. The car park advertised by the owners can take 20 cars at most and all other nearby parking is for residents only.

The owners' promotional video describes a capacity of 3,200, offering regular services, after school classes and lectures. It also tells how attendances at the previous centre in Cricklewood outgrew the 600 of capacity, necessitating a larger centre. Both toxic gases and noise pollution are already a problem in the area. With events and services going on well into the night and starting in the early morning, the noise of crowds arriving and leaving the area were and will in the future be unavoidable, however well intentioned the plan is to avoid this.

The local communities are already well served by existing Churches, Synagogues, Temples and Mosques. A large Mosque catering mostly for attendees from out of area, is surplus to needs in this conservation area. The Golders Green Hippodrome, an iconic, imposing, Grade II listed building, typical of its period, must not be selective, but returned to its original use for all communities. It is not suitable for use as a place of worship for a single religious community be they Christian, Jewish, Hindu or Muslim. Word has it that Middlesex University in Hendon is looking for a theatre and arts centre. The Hippodrome would provide an ideal site, preserving it for its original historic use.

The site itself does not have the car parking capacity to support this use meaning the surrounding, largely residential, streets are pushed well beyond acceptable stress levels. These residential streets are not an appropriate car parking solution for the centre

While Golders Green is well served by public transport, the reality since the opening of the centre shows that private vehicle appears to be the dominant form of transport for visitors

When there are events attracting large numbers (often in the evenings), there are too many cars trying to park on the residential streets. The result is issues of availability of parking bays / yellow lines for residents; regular instances of inconsiderate and often illegal parking making access to driveways difficult; traffic volumes on roads that are not designed for these levels of car use leading to congestion, excessive vehicle noise and exhaust; excessive activity and noise (car doors, horns, engines and people) at antisocial hours as some events do not finish until late at night leading to largescale return to vehicles on residential streets at 11pm / midnight; more littering than is usual due to influxes of non-residents to these residential streets

The transport assessment is at best inadequate and at worst misleading. For eg, the centre has been operating for some time so there has been ample opportunity for a full assessment of the transport methods used by visitors and traffic / parking impact on the local area - it is more significant and negative than portrayed in the report. The use of 'TRICS community use' category

for comparison of trip use is misleading as it does not capture the real patterns of the centre's use incl at night

I wish to object to the planning application to turn the Golders Green Hippodrome away from its Primary purpose, that of providing an entertainment venue par excellence for North West London. I have lived in the borough for 70 years and have seen the demise of all of the entertainment venues in the area, pushing them out to North Finchley; Swiss Cottage etc. The Hippodrome was a place of live entertainment, plays, concerts and Pantomime. I used to take my children there and it provided a unique opportunity for entertainment at all levels.

How have the mighty fallen. Barnet Council has overseen the total destruction of local entertainment in the area. The Gala Cinema in Brent Street closed in 1967 to become the Sentinel Square Shopping Centre. The closure of the Odeon cinema at the Quadrant in Hendon in 1979 was followed by its demolition and replacement with sheltered housing in 1981. The Odeon cinema in Temple Fortune, replaced by a block of flats in 1982; the Cannon / ABC cinema on Golders Green Road closed in 1987 to be replaced by residential accommodation for the elderly. The Gaumont / ABC cinema at Hendon Central closed its doors to cinema goers in 1997 when it converted to a Gym and then Health Club / Centre and finally, the nail in the coffin of local entertainment was the lonic cinema, one of the first cinemas in the country, demolished to make way for a new Sainsbury is in 1979. The demolition was allowed by planning on the condition that Sainsbury incorporate a new cinema into the design of their new store. This was closed by Sainsbury is for extension of their supermarket in 1999. Planning was agreed for all of these situations for commercial considerations in spite of the detriment to the residents of the area. The Odeons had stages that had been used for shows e.g. The Odeon in Temple Fortune staged Pantomimes and other productions and famously put on the Gang Show each year which Her Majesty the Queen attended in 1972.

Only the Hippodrome remains. It should not be designated for one group, it should be available for all to enjoy, a cultural centre for everyone. It should have plays for young and old; school children should be able to learn from it the art of theatre, putting on their own plays perhaps. Repertory theatre should be invited back to put on productions in the environment for which the Hippodrome was created and functioned, not just in the West End of London where prices and the journey put many off from attending. The sound of the young should be encouraged to be heard and life brought back to the

building in an age where there is now a dearth of live entertainment anywhere accessible to the residents of the area, or even in the entirety of North London.


In 2005 plans were advanced for conversion of the building into a Jewish centre or an IT and media hub. Both applications were rejected by Barnet Council who stipulated that the building had to be retained for entertainment use only. However it was allowed to be taken over by a Church group provided that some live entertainment would be provided. No such entertainment resulted and the building was allowed to fall into disrepair. By 2018 the building was operating as a mosque.

Barnet Planning Department and the Council as a whole have failed to ensure their stipulations for Planning consent have been followed. Sainsbury a have ridden roughshod over the stipulation that the lonic Cinema should be maintained whilst the Church group failed to adhere to the stipulation that entertainment should be provided from the Hippodrome.

Little is available for entertainment for the young in the area. Nothing is available for the older residents. It is for the Councillors and Planning Department of Barnet to call a halt to this wanton destruction and provide a safe and welcoming place for all of the residents of the area, the ones who pay the Council Taxes of Barnet and for whom few such amenities are being provided or encouraged. The Hippodrome exists as such an amenity, efforts should be made urgently to restore it and use it to its fullest potential for the Community as a whole.

Dear Sirs,

I strongly object to a change of use to a place of worship. Without other provision in place, West Heath Drive ("**WHD**") and the surrounding streets will become the de facto car park for the Hippodrome. From what we've seen when the centre was last opened, prior to the current restrictions being put in place, that's not a workable arrangement. It had a severe negative impact and caused an incredible amount of disruption to the area, with the increased traffic, congestion, noise, littering, disruption to the normal working of public transport, intimidating groups of young men hanging around, parking on driveways, blocking of driveways and parking on single and double yellow lines. The area is already congested with parked cars and traffic on WHD and the surrounding streets.

Apart from parking or related issues, to have such crowds and potential noise as was the case previously when the centre was open is not in my belief, conducive to a mainly residential area of Golders Green and certainly in my case, will not help my kids to get the sleep they need during school days.

Also, part of the issue with the new centre becoming a place of "worship" is that the influx of people from outside the local area would not be limited to one time of day or one day a week. The mosque would no doubt be running services and large events throughout the week, meaning the impact is ongoing, not just on Sundays or at particular times like it was for its previous use as a "church". The change of use proposed has wide implications that needs a much bigger consultation, thought and restrictions to be put in place to protect local residents from the huge extra number of cars that result. When the centre was a Christian church, the attendees of that church were of a much smaller number and were always considerate to the local area and residents. Also, the church was only used at limited times.

This new centre has already proven that a potential change to the use of the building is massively detrimental; that attendee numbers vastly increased; and that those attendees are completely inconsiderate of their impact to the local area. The use of the building as a mosque has already created a completely different and more disruptive pattern of use. This is not about the faith that is being practised at the Hippodrome, its about the fact that the congregation have already proved that they are incapable of being considerate toward the local community, and the management of the building are unable to mitigate the deterioration of the quality of life of the residents of this once charming and tranquil neighbourhood.

I was surprised to receive your letter of 25 January concerning yet another planning application for a change of use for the Golders Green Hippodrome to allow a mosque. Given the strength of feeling generated by the original application and subsequent consultation, a Public Inquiry would seem the only way that the matter can be seen to be decided openly and fairly. The Council should therefore turn down this application and let the Inquiry take place as and when circumstances allow. I sympathise with the applicants who clearly want to find resolution; however, the pandemic affects us all and we must all learn to bide our time.

I am not religiously prejudiced and am not Jewish; however, it is clear that the proposal for a mosque in the middle of a long-established orthodox Jewish community could be construed as provocative.

A few further comments:

- 1. There is no significant local Muslim community. The mosque would therefore be attracting visitors from outside the local area who are not within walking distance of Golders Green.
- 2. The proposed opening hours are considerably longer (08.00h 23.30h) than any usual community centre or church. I therefore understand the concerns of residents who live nearby: they have clearly been inconvenienced in the past by inconsiderate parking, littering and noise late into the night. Morning opening would coincide with rush hour when large numbers of commuters go to the tube and bus yard; and evening closing would extend well beyond the normal night-time 'noise' curfew of 23.00h.

- 3. The mosque and community centre will inevitably draw more traffic to an already polluted and frequently congested area; particularly in the evenings and at week-ends when people are less inclined to use public transport.
- 4. It will put further pressure on parking in an area where it is notoriously difficult to park at the best of times and where local residents should, quite reasonably, be able to find parking to do their shopping and go out in the evening. I understand that in the past, the mosque has been using the Sainsbury's car park. Although this is perhaps an issue for Sainsbury's to resolve, it is not appropriate to abuse facilities which should rightly be reserved for shoppers.
- 5. The application appears to be for a much smaller congregation of worshippers (150) than was originally the case; however, given the size of The Hippodrome and previous non-compliance with the terms of use, there is no guarantee that the number would be adhered to. Allowing the application could be the thin end of the wedge and lead to further applications in the future to increase the congregation.
- 6. Barnet has, in some ways, brought this predicament on itself by refusing a change of use to the BBC. Whilst I do not know the detail of the proposed change of use, the BBC is a national service provider whose mission it is to "to act in the public interest, serving all audiences through the provision of impartial, high-quality and distinctive output and services which inform, educate and entertain": to that extent, the BBC would have continued to serve the nation and the local community.
- 7. The term 'ancillary community uses' used in the application is unclear. It is also unclear which 'community' the centre proposes to serve.
- 8. The Hippodrome is a local asset which was originally designed as an entertainment venue for local residents. It should be revived as an asset for the whole community and used to drive the regeneration of Golders Green: this is long overdue. The Hippodrome could be re-structured to provide : artisan studios; a cinema; a pocket theatre; a community centre for the elderly; a playgroup; a library; an adult education centre. The closure of the Hampstead Garden Suburb Institute was a great loss to the local community and the Hippodrome could offer a range of well-targeted courses to help re-train and upskill those seeking new employment opportunities. There are many whose education and opportunities have suffered as a result of the pandemic. In this way, the Hippodrome would provide a useful service to the whole community and lead to the rejuvenation of Golders Green.

At a time when we are all being urged to drive less and 'shop local', it is essential that the GGR be re-vitalised. 





I am most concerned about the proposal to turn the iconic Hippodrome into 'one of the largest Islamic Centres in Europe'.

As a very long term resident of this area, I can well remember being taken to the Hippodrome as a child to see pre West End productions of many shows, including 'The Gang Show' (Scouts and Guides), Gilbert and Sullivan operas, pantomimes and many others. It was also, for some time, the home of one of the BBC's orchestras.

The point of these recollections is to show that they were for the benefit and enjoyment of <u>all</u>, and <u>not limited to one particular group</u> as is the intention now. I call that grossly unfair to local residents, indeed to Londoners in general. I would like to think that one day some of these amenities may return, albeit in a different form. After all, that was the undoubted original intention of the building - <u>public</u>enjoyment !

Golders Green, while not being exactly a rural area, nevertheless has a certain atmosphere of suburbia about it which is cherished by residents and visitors alike and has just about enough traffic and vital activity to suit. It simply cannot accommodate the huge extra footfall which this proposal would undoubtedly generate. Already parking is a just about manageable issue and the extra noise and disturbance created would be intolerable - some of it I gather, would be late at night. The extra pollution caused would certainly fly in the face of the emerging demand and need for greener, cleaner air.

The residents of the roads opposite The Hippodrome have already found parking and noise difficult to deal with during its unauthorised use. This could only intensify if this planning permission is approved.

In regards to the application in the subject, please see my comments below.

I pass this site twice a day, almost every day. I am very worried of the proposed changes to the site listed in the application for the following reasons.

1. The building and it's character should be a joy to all communities not just one part of it. It will remove the choice for communities to host performances, events and otherwise be used as a neutral community centre for all, and will irreversibly damage the buildings heritage.

2. The number of people for a small area with minimal parking will - whether you intend it to or not, and think they'll use public transport -actually attract hundreds of cars to a limited space. It will cause traffic obstructions and horrifying congestion in an already congested area. It's unrealistic to believe that the members of this suggested mosque will all be using public transport when the reality is many will be using cars. With most of the surrounding areas permit holders the drivers of these cars will have no choice but to obstruct traffic or even park in restricted areas. I also ask you to consider the amount of pollution this kind of congestion would add to the area. The suggested closing hour of 23.30 will also mean many won't even have the option to use public transport due to closing hours of the tube. 3.As the suggested closing hours are 23.30 the noise pollution and disturbance to the immediate and surrounding areas will be unbearable and highly uncomfortable for local residents. If it only closes at 23.30, noise will continue much past midnight. This is a quiet, family area and this would be a huge disturbance and repel families from settling in the area.



The members mostly live locally and have escaped repression like so many Jewish people locally. There are parallels which bring us together.


