Absolutely adamant that he would not support the idea of a school and understood why a Care Home may not be suitable due to Hendon Hall, Hammerson Nightingale, 58 TBA, new one being considered in Hampstead lane.

He wanted a copy of our consultation letter so he could email vociferous neighbours directly with it. He wanted an assurance (which we gave him) that the residential scheme would be our preference and he would communicate this to the neighbours.

Generally presented the scheme and explained that we were considering a 7 storey building with upper storeys set back and it would be designed to avoid any overlooking issues. He said that it would be unwise to go against the neighbours. He liked the idea of smaller apartments suitable for empty nesters / downsizers freeing up family homes – Cllr Zinkin said he and his wife qualified!

We discussed affordable on site and he said that he understood and he would support a PIL. However we should be prepared for some resistance from the Labour Councillor – we are speaking to her next Monday. Also we should consider working with or supporting Barnet Homes proposed scheme in Granville Road.

Overall he gave us his qualified support subject to the above.

Alex will prepare a proper file note.

We discussed affordable on site and he said that he understood and he would support a PIL. However we should be prepared for some resistance from the Labour Councillor – we are speaking to her next Monday. Also we should consider working with or supporting Barnet Homes proposed scheme in Granville Road.

Overall he gave us his qualified support subject to the above.

Alex will prepare a proper file note.

Please can we have a date for the Teams Call with Fabien and Cllr Ryde – holiday season so I need to ensure all can attend.
