Thank you for your notification re the above waiting restrictions proposal at Edgeworth Close. Several years ago I signed a petition regarding parking permits in our street. The reasons for the objection were that the residents do not have off – street parking, and that permits would be only for one side of street. This was upheld. Nothing has changed in this respect.

I appreciate that emergency and local authority vehicles should have reasonable access but with double yellow lines, where will the residents park. Only block 81 - 85 has off - street parking. I acknowledge that some restrictions may be needed.

I have copied your plan and return it to your department with some comments. There are also some anomalies concerning disabled parking bays eg. there is only 1 bay (near block 3/4) on the north/south leg of the 'T', and none near block 63/64.


I would like to suggest that if there has to be a parking restriction (a single yellow line?), it should be sited on the north side of the 'T' where the garden of 55 Edgeworth Crescent faces the Close and there is only one residents' entrance. This would also be a help to pedestrians as the pavement is very narrow and can be quite hazardous if one has a pram or wheelchair.

It would also be a shame to restrict parking where the oak tree stood as this has provided valuable parking space for the residents – since the tree was felled, now 1 more, car can park where the stump lay.

We have received a road plan with proposed waiting restrictions for Edgeworth Close. Whilst we welcome a favourable outcome of the restricted parking and the difficulties we currently face with delivery vans/refuse collections getting into our Centre, we would like to point out that there are also daily problems with vehicles parking on both sides of the road, this being the section of Edgeworth Close entering from either Edgeworth Crescent or Talbot Crescent, as again the current parking situation creates problems for larger vehicles being able to drive through. In the event of any emergency vehicle attempting to get through, it would be virtually impossible. The lines will also restrict people using this location to park their cars and walk to the Thameslink station.

We therefore further suggest that yellow lines are also implemented (see attached copy highlighted) on the non-residential side of Edgeworth Close.
