

I like the look of the Phase 1 and 2 pilots, but may I suggest you expand the scope of the areas you are looking at for each of these stages, to make the most of the planning and partnership working.</p> <p>Can I also suggest you take a look at the Pursley Road area near Dollis Infant School as we've had a number of residents and staff who live in that location talking about the very poor broadband speeds (currently they get between 10 and 30MB maximum speeds). 



Unfortunately, the way we would deal with this would be through land registry searches, as council tax information will all relate to the leaseholders.

Our understanding of installations more generally is that:

- (1) Several companies digging their own ducts will leave access points at intervals along the street, and then only install the last stage connection to the rented property when a permission is granted (i.e. service is purchased, which might involve a signature from the freeholder/landlord if the law doesn't grant that right to the tenant). You'd need to find out how companies like Virgin Media and G.Network deal with this.
- (2) You can make use of PIA (Physical Infrastructure Access) from Openreach where the property is directly connected via the Openreach ducting (e.g. you can cable to the rented property along the route of the telephone pole or underground cable/duct, and install a line to the property attached to the existing telephone wire or via the existing duct).
- (3) The only blocks where you will need explicit landlord permission/wayleave first should be those where you have to cross 'common' land (shared corridors, risers, dig up shared outdoor spaces).

You will only have to do 1x Land Registry search per block to understand whom is the freeholder as it should be clearly listed.

I hope that gives a few helpful pointers. I suggest if you still have concerns then you should get some professional legal advice about your options and the best ways of securing the appropriate permissions.






