Dear Sir/Madam,

I would like to bring to your attention development work taking place at site: [REDACTED], that is resulting in damage to the pavement - arising from the collecting/depositing of a skip on a near daily basis and placement of a Skip on the pathway. This has resulted in the sinking/cracking of the pavement slabs.

The council have repeatedly replaced these slabs during the first round of development at the site last year, only for them to be damaged again – this is hugely upsetting and a waste of council resource given the council is not liable for the damage caused by the household.

I trust this will be investigated given the evidence provided.
