The council currently have in place various service specific enforcement policies and procedures for the respective delivery units who have a duty of care regarding enforcement.

The Corporate Enforcement and Prosecution Policy will ensure there is a consistent approach to enforcement and prosecution by the council and any other organisation delivering regulatory/enforcement services on behalf of the council, therefore ensuring Council compliance with the Cabinet Office Enforcement Concordat and the Statutory Code for Regulators introduced in 2014.

The Corporate Enforcement and Prosecution Policy is embedded into all services areas one

way of measuring the impact will be the collation and assessment of the tools and powers used broken down by demographic and assessing against the assessment strands identified.

Data recording of those persons dealt with by way of this power will be recorded on police and council case management IT systems but in the most part the use of this powers will be recorded on ECINS – the council’s and partnership IT ASB platform.

The officers of the Council’s Community Safety Team and Neighbourhood Policing Team will agree the programme of operational deployment of Partnership officers to affect a consistent and sustained enforcement of the PSPO.

This borough wide PSPO will also be subject to an annual review and this will form part of the Annual Community Safety Team report submitted to the CLLC and shall be reviewed and approved by the authorising Director, the Executive Director of Assurance as part of the for Environment as part of the annual review process of the PSPOs.

This introduction of this PSPO is necessary to reduce unlawful activity and keep open spaces accessible and safe for all the residents of Barnet. The Council considers the action is justified but will review the findings and the EIA on a case-by-case basis when any negative impact on particular protected characteristics is identified.

All learning from this power will inform adjustment to practice and use of this PSPO power for best practice and ensuring the updated EIA reflects the due regard legally required.

**9. Please give a full explanation for how the initial assessment and outcome was decided.**

As referred to in section 5 above, the actual impact on service users is not yet known because the detail of how the PSPO will affect the community and visitors to the borough is not known.

However, there are eight service user groups with protected characteristics that have been identified as having the potential to be impacted by the Corporate Enforcement and Prosecution Policy as noted in section 4 above.

These groups are:

- All ages above 10 years old
- People whose first language is not English
- People who do not speak English as a first language (or at all)
- People with mental health issues
- Unemployed people
- Young people not in employment education or training

These groups have been noted because they are potentially affected by the imposition of this power (PSPO).

However, it is not yet known if these groups will definitely be affected and, if so, to what extent.
