Thank you for your request received on 25 April 2019, for the following information:

Planning enforcement action against short-term lets

I'm seeking details of enforcement action taken by your authority's planning team in relation to properties offered for short-term lets via platforms such as Airbnb.

Please could you provide the following under the Freedom of Information Act:

The number of planning enforcement notices issued by your authority in relation to short-term lets in each financial year from 2011/12 to 2018/19.

The number of planning contravention notices issued by your authority in relation to short-term lets in each financial year from 2011/12 to 2018/19.

If available, please also provide the number of informal warnings issued by your authority's planning team in relation to short-term lets in each financial year from 2011/12 to 2018/19.

We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested. However, we consider that the following exceptions apply to some of the information requested.

The Council do not record complaints in a manner that would allow to easily draw the information requested out.

Cases involving Air BnB in any form are still very rare within this borough. The Council hold information on planning enforcement cases between 2011 to present but it is in a free text field and cannot be searched without entering the exact wording of each case description. Identifying whether a PCN has been served or a warning issued would require going through each enforcement case and in our view this would be manifestly unreasonable as this would amount to checking thousands of enforcement cases.

Refusal Notice

We consider that Regulation 6(1)(b) applies to some of the information requested because the information requested is already publicly available and easily accessible.

We consider that regulation 12 (4) (a) (Information not held) applies to the information requested because we do not hold the information requested. We do not hold centralised records of the numbers of PCNs and warnings issued. The ICO have stated that they do not expect a public authority to undertake a public interest test where they do not hold the information.

We consider that regulation 12 (4) (b) (Manifestly unreasonable) applies to the information requested because we consider that the request is manifestly unreasonable.

Information not held in the format requested. Each indvidual enforcment case file would need to be searched in order to locate this information and counted.

In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

Factors in favour of disclosure

Promoting accountability and transparency by public authorities for decisions taken by them.

Promoting accountability and transparency in the spending of public money.

- Allowing individuals, companies and other bodies to understand decisions made by public authorities affecting their lives.
- Furthering the understanding and participation in the public debate of issues of the day.

Factors in favour of withholding

 Complying with the request is unreasonable because the inconvenience, disruption and burden on the council is too high. Compliance will distract officers from their other jobs, will take up too much council resource and is disproportionate effort for the benefits given.

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
