Thank you for your request received on 5 June 2019, for the following information:

Please provide me with information regarding temporary accommodation provided by the council over the last three financial years: 2017/18, 2016/17 and 2015/16

For each of the financial years listed, please tell me:

- 1. The number of people placed in temporary accommodation after making a homeless application
- 2. The number of temporary accommodation properties, broken down by category (such as hotels, B&Bs etc.)
- 3. The average (mean) length of stay in a temporary accommodation after making homelessness application
- 4. The five shortest and five longest stays in temporary accommodation after making homelessness application
- 5. The total costs to the council of temporary accommodation broken down by the same categories as question 2

Please excuse the email if this was wrongly directly. If you can please pass me on to the relevant person overlooking this process.

We have processed this request under the Freedom of Information Act 2000.

### Response

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

I have searched with services and they have confirmed that the information is held by Barnet Homes.

Housing services (including homelessness, allocations, housing repairs and so forth) are provided by Barnet Homes who are an Arm's Length Management Organisation (ALMO) who manage the council's housing stock and associated services on the council's behalf.
