Thank you for your request received on 25 June 2019, for the following information:

Please provide me with the number of road traffic accidents on East End Road between East Finchley High Road and Regent's Park Road.

Please also provide the following details

- how many people were involved,
- what were the ages
- what modes of transport were being used including pedestrians
- the time of day of the accident
- how severe the accidents were notably if fatal or life changing
- were there any prosecutions made as a result of the road traffic accidents
- how many drivers were reported as using mobile phones at the time of the road traffic accident

We have processed this request under the Freedom of Information Act 2000.

Response

Please provide me with the number of road traffic accidents on East End Road between East Finchley High Road and Regent's Park Road.

There are 27 Personal Injury Collisions recorded on East End Road in the most recent three years data available to us (to 31 December 2018). This excludes the junctions at each end (i.e. with A1000 High Road and A598 Regents Park Road

Please also provide the following details

- how many people were involved,

We do not know exactly how many people were involved, but there were 35 casualties and 21 other people (usually vehicle drivers) recorded in the data (see table below)

- what were the ages

- what modes of transport were being used including pedestrians

- the time of day of the accident
- how severe the accidents were notably if fatal or life changing
 For injuries categorised as serious we do not know whether these were life changing.

- were there any prosecutions made as a result of the road traffic accidents

This information is not available to us.

- how many drivers were reported as using mobile phones at the time of the road traffic accident

This information is not available to us, but none of the collisions record "Driver using mobile phone" as a contributory factor

In addition we have received information from the police about a recent child fatality that has been reported in the press. This involved a 3 year old pedestrian and a car. We do not know the ages of the driver or the child's escort. This occurred at 19:04 and we have no information to indicate that a mobile phone was being used.
