Thank you for your request received on 18 June 2019, for the following information: This is an information request relating to artwork owned by your local authority. Please provide the following information: ☐ How many artworks have been purchased by the local authority in 2016-17, 2017-18 and 2018-19? ☐ How many artworks are in the possession of the local authority? ☐ What is the estimated value of the artworks? ☐ How many of the artworks are on public display? Public display includes those that can be viewed by the members of the public in local authority buildings such as council headquarters, libraries, sports and leisure centres, and schools that are under local authority control. It would exclude areas of council properties that cannot be readily be entered into by members of the public (such as, for example, the office of the head of paid service). Artwork includes, but is not limited to, paintings, photographs, sculptures and electronic art. We have processed this request under the Freedom of Information Act 2000. in local authority buildings such as council headquarters, libraries, sports and leisure centres, and schools that are under local authority control. It would exclude areas of council properties that cannot be readily be entered into by members of the public (such as, for example, the office of the head of paid service).

Artwork includes, but is not limited to, paintings, photographs, sculptures and electronic art.

The borough has a few paintings on the walls of the Town hall. (The three oils of former Alderman on the stairs) numerous photographic prints of Mayor's and their Escorts in the corridors and prints of the Queen and Prince Philip.

In the Mayor's parlour there is a landscape painting unsigned and a wall mounted stone carving from Montclair.

These items have not been valued as the Authority believed in 2007 that the benefits of obtaining the valuation for these items would not justify the cost. They are therefore not included in the asset register.

There are two statues that are owned and maintained by the borough that might be classified as work of art. The Family of Man statue was presented to the borough in 1981. More information is published by Local Studies at:

La Deliverance or the Naked Lady statue was made to celebrate the French victory at the first battle of the Marne when the German army was stopped from capturing Paris in August 1914. In 1920 it was bought by Lord Rothermere who presented it to Finchley. It was valued at £266,000 in 2015. More information is available at:
