Thank you for your request received on 12 June 2019, for the following information:

I am the agent in regards to a planning application for development proposals on land to the rear of 85-87 Hodford Road, London, NW11 8NH. The planning application ref is 19/1904/FUL.

We have been notified by our case officer, Denisse Patten, that there have been 5 objections on the application. Whilst 3 are appearing online, the remaining two were sent by post or email, and we have been advised that a freedom of information request is required to view these objections. I'd be grateful if you could send these through at your earliest convenience please, as the application is live and it would be great to have sight of these asap.

Please let me know if there is anything further you need.

We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested. However, we are withholding some of that information since we consider that the following exceptions apply to it.

Refusal Notice Part 1 of Schedule 19 of the Data Protection Act 2018 amends the personal data exception Regulation 13 of the Environmental Information Regulations 2004. These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They will not fundamentally impact when personal data can, and cannot, be disclosed in response to an EIR request. We consider the information is subject to Regulation 13 because to release it would be a breach of the Data Protection Act 2018. Personal Information is governed by the Data Protection legislation and is defined as any information relating to an identified or identifiable natural person ('data subject')". It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person. The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the

requested information would breach this principle and in particular the requirement of fairness.

Please see attached document containing some of the objection letters received for the Planning Application: 19/1904/FUL. The blank pages are due to the scanning method that was used.

We consider that Regulation 6(1)(b) applies to the information requested because the information requested is already publicly available and easily accessible. If you do not have access to the internet at home, you may be able to use facilities at your local library.
