Thank you for your request received on 1 July 2019, for the following information:

I would like to make the following request for information:

1. Please state whether you have used the Environmental Protection Act 1990 to restrict the distribution of free printed matter (leafleting). If so, please state the cost of obtaining a leafleting licence. Please state whether you apply these restrictions to small local arts and community groups (for example a local theatre or arts group).

2. Please state whether there are any additional restrictions in your town or city centre on leafleting on behalf of religious/charity/political groups.

3. Please state whether there are public open-air areas within your city or town centre which are owned and controlled by private companies (for example, a square or a park). If possible, please state the number of these areas. Please state whether you are aware of any restrictions in these areas upon freedom of speech or association (for example, restrictions on leafleting, political demonstrations, gathering in groups, charity fundraising, or on megaphones or amplification).

4. Please state whether you have taken down or issued warnings for posters put up by community/religious/charitable/political groups, or for local events. Please give a list of all such posters taken down in the past year. Please provide as much detail as is possible (eg, the name of the community group concerned, and the action taken).

5. Please state whether there is a free public noticeboard within your town or city centre where people can put up posters.

6. Please state whether your council has an area in the town centre where people could put up a temporary stall (for example, to campaign on a political cause). Would a fee be payable to the council for this? (and if so, how much?).

We have processed this request under the Environmental Information Regulations 2004.

Response

I am writing to inform you that we have searched our records and although we hold some of the information requested, some is not held by London Borough of Barnet.

We have provided answers to your request below showing where we do not hold the information requested.

I would like to make the following request for information:

1. Please state whether you have used the Environmental Protection Act 1990 to restrict the distribution of free printed matter (leafleting). If so, please state the cost of obtaining a leafleting licence. Please state whether you apply these restrictions to small local arts and community groups (for example a local theatre or arts group).

No we have not and I can also confirm that Regulatory Services have not taken any such action to restrict this type of activity.

2. Please state whether there are any additional restrictions in your town or city centre on leafleting on behalf of religious/charity/political groups.

No I am not aware of any such restrictions.

3. Please state whether there are public open-air areas within your city or town centre which are owned and controlled by private companies (for example, a square or a park). If possible, please state the number of these areas. Please state whether you are aware of any restrictions in these areas upon freedom of speech or association (for example, restrictions on leafleting, political demonstrations, gathering in groups, charity fund-raising, or on megaphones or amplification).

Not that can be ascertained.

Regulatory Services have not taken down or taken any action against fly posters. We would intervene and either stop or take down/ remove anything that incites racial hatred or hate crime.

5. Please state whether there is a free public noticeboard within your town or city centre where people can put up posters.

None as far as I can ascertain.

6. Please state whether your council has an area in the town centre where people could put up a temporary stall (for example, to campaign on a political cause). Would a fee be payable to the council for this? (and if so, how much?).

We utilise legislation under the London Local Authorities Act 1990 and Highways Act to licence stalls, tables and chairs and advertising "A" boards. If these were

applicable in this case there would be a charge in line with our fee schedule which can be found on-line.

Regulatory Services issue licences for street trading and tackle unauthorised street trading / obstructions on the highway. It would very much depend upon the circumstances and detail of the proposed activities as to whether such a stall would be granted a licence. We suggest that applicants contact the Licensing team in the first instance to discuss the application. Fees are charged in line with our advertised rates.
