Insofar as may be relevant to the request, the Building Control function in this instance was contracted out to NHBC Building Control Ltd, an Approved Inspector. It should be open to the council under the terms of the contract on which NHBC Building Control were appointed to carry out building control services, to request copies of all documents from NHBC Building Control Ltd that would otherwise be subject to the Freedom of Information Act 2000. Please kindly confirm you will obtain copies of the documents in question from NHBC Building Control Ltd accordingly, and that you will then supply me with copies of the documents in question without delay.

Further or alternatively, please accept this as a Freedom of Information request for a copy of the council's contract appointing NHBC Building Control Ltd as an Approved Inspector, as soon as possible and in any event within 20 working days.

We have processed this request under the Environmental Information Regulations 2004.

The Building Control Application that covered the construction of her property was an Initial Notice (Barnet Case Ref: I/13/00731) received from an Approved Inspector (NHBC). Approved Inspectors are persons or companies authorized under the Building Act 1984 to carry out Building Control work in England and Wales. Once an Approved Inspector files an Initial Notice with the council (this a document informing the council that supervisable works will be taking place and that they will be overseen by the Approved Inspector) then the Approved Inspector and not Barnet Council's Building Control Department oversee the Building Regulations for the project.

The council does not appoint the Approved Inspector, and does not have a contract with them. They are appointed by the applicant.
