The council holds the information requested and the answers to your questions are below:

As at 21.07.19:

<u>Incoming OT assessments – excluding DFG referrals :</u>

There are 402 referrals awaiting OT assessment.

Of these the longest waiting for an assessment is 29 March 2019

Out of 402, 107 are for the provision of major adaptation,

12 non urgent manual handling reviews

and the remaining 283 referrals are for equipment and minor adaptation provision.

Urgent manual handling requests are referred and dealt with by short term OT access Team with assessments completed within 5 working days.

Paediatric assessments are completed by Family Services. See attachment.

2. We have not used any external OT organisation in the past 12 months.
