Thank you for your request received on 4 July 2019, for the following information:

Please could I have the figures spent on funding debt, housing and welfare benefits advice for each complete year since 2009-10.

If possible, I would like these figures separated across the three areas.

As relevant, I would also like them separated into what proportion of the money supported services provided internally and externally.

We have processed this request under the Freedom of Information Act 2000.

Response

I am writing to inform you that we have searched our records and although we hold some of the information requested, some is not held by London Borough of Barnet because figures can only be supplied from 2013 for Welfare Benefits Advice internal funding (due to the 6 year retention period) and from 2015 for Welfare Benefits Advice external funding as this is when it began.

We have provided answers to your request below showing where we do not hold the information requested.

Please could I have the figures spent on funding debt, housing and welfare benefits advice for each complete year since 2009-10.

If possible, I would like these figures separated across the three areas.

As relevant, I would also like them separated into what proportion of the money supported services provided internally and externally.
