#### Response

# 1/ How many schools are signed up for School Streets on a) a permanent basis or b) a trial basis, and how many schools are there in the council?

We are not aware of any schools signed up for School Streets, but as there are 128 schools in Barnet you should contact each school separately to confirm whether or not is the case:

# 2/ How many cycle hangers are there in the council and what is their total capacity?

There is one on-road cycle hangar in Barnet with a capacity of 6 bikes. There are also a further 31 cycle hangars each with a capacity to park 6 bikes at Barnet Homes (social housing) locations around the borough providing a total of 186 cycle parking spaces.

### 3/ What is the total number of people on waiting lists for cycle hangers in your council?

There are currently no people on the waiting list for cycle hangars in Barnet.

# 4/ In total, how many public charging points for electronic vehicles have been installed in your council? How many will be installed in the next 12 months?

40 Lamp Column mounted EV Chargers – 3.5kW.

A further 40 locations are planned in the next 12 months.

54 Stand Alone Electric Vehicle Chargers were installed in May 2019 at:

A further 8 are to be installed in the next 12months

#### 5/ Do you have legislation that allows you to enforce idling vehicles?

Legislation exists but LBB Parking does not enforce vehicle idling under PCN Code V6.7.7.
