Thank you for your request received on 28 June 2019, for the following information:

**How many tickets issued at location 7454 since 23rd April for not paying to park using pay by phone app.**

We have processed this request under the Freedom of Information Act 2000.

**Response**

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet in a reportable form.

The PaybyPhone location reference is not recorded in a manner that it can be automatically reported upon with regards to numbers of Penalty Charge Notices' issued.

6002 Penalty Charge Notice's (PCN's) were issued due a vehicle not paying to park since 23/04/2019 within Barnet. Each PCN would have to gone through manually and the PayByPhone location (7454) recorded in order to ascertain the information required. This would take on average 1 minute per PCN and would take a total time of 100 hours.
