The council holds the information requested and it is attached/ the answers to your questions are below

***\* A full total and breakdown of money spent on LGBT+ paraphernalia by the council in the past five financial years.***

Barnet Council is proud of our diverse communities and supports Barnet being an inclusive and welcoming place where all of our communities co-exist happily. Like all public bodies we are bound by law to advance equality of opportunity for everyone in our borough who shares a protected characteristic as defined in the Equality Act 2010, and to foster good relations between these groups and other members of our community. While sexual orientation is one of the characteristics, we have not specifically funded training, events, awareness raising or individual organisations that has been solely focused on LGBT+. This would be included within our general approach to equalities, diversity and inclusion (EDI).

This year we flew the rainbow flag from some council buildings to mark Pride month.

The total cost of purchasing three flags was £169.85. This was promoted through our social media channels, but except for staff time there was no financial cost to this.

We have also fundraised through a cake sale during Pride in support of the charity Switchboard.

In 2018 our Barnet Equalities Allies (NEA) held a staff awareness-raising event to celebrate LGBT History Month.

BEA are a voluntary group who gave their own time to this at no cost to the council
