Please give me copies of all emails by the Communications Team regarding the decision to run this campaign, and any correspondence relating to the campaign with the Leader of the council, or Chief Executive.

We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below and attached.

Hello: I would like to make the following request under the Freedom of Information act:

Please tell me how much the current 'Together we are Barnet' campaign is costing?

(NB Please do not reply by saying this is impossible to quantify as you may use the same method used to suggest it costs £42K to answer residents' questions to committees and Forums). The Together, we are Barnet campaign has cost £9,430 to date. Please note that the campaign is being run with our strategic partners, the majority of whom are also making a £1,000 financial contribution. The CMT Partners are: NHS Barnet Clinical Commissioning Group, Metropolitan Police, Saracens Rugby Club, West London Business, Inclusion Barnet, Groundwork, Federation of Small Businesses, Argent, Middlesex University, the Department for Work and Pensions, Barnet and Southgate College, and Brent Cross Shopping Centre.

Was this campaign produced as a result of any external support e.g. consultants? If so, how much did that cost?

The campaign was conceived, developed and executed by Barnet Council's inhouse communications and strategy teams, with no support from external consultancy agencies.

Please give me copies of all emails by the Communications Team regarding the decision to run this campaign, and any correspondence relating to the campaign with the Leader of the council, or Chief Executive.

Please see attached. No time frame was specified in the request but all emails identified as being in scope have been supplied. The names and personal details of third parties and the names officers who are not in the public domain have been redacted.

Refusal Notice Section 40(2)

Part 1 of Schedule 19 of the Data Protection Act 2018 amends the personal data exemption under section 40 of the Freedom of Information Act 2000(FOI). These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They will not fundamentally impact when personal data can, and cannot, be disclosed in response to an FOI request.

Personal Information is governed by the Data Protection Act legislation and is defined as any information relating to an identified or identifiable natural person ('data subject')". It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an on-line identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness.

Because individuals working for the council have a reasonable expectation of privacy and do not expect that the council would disclose their names or contact details in response to a freedom of information request, especially as they are relatively junior and not in public facing roles. The council's redaction policy states that officers' names and contact details under the level of Assistant Director will generally not be released. All of the posts redacted are under the Assistant Director level.
