Thank you for your request received on 1 August 2019, for the following information:

I would like to know how many Managed Moves took place in your Local Authority between the years of 16-17 or 17-18 if this is available. I would just like the total number per year as I am hoping to gain a wider perspective on how much they are being used. This will be used within a thesis write up containing a generic reference to how many are being used across multiple Local Authorities and will contain no identifiable information under the FOI request.

Response

I would like to know how many Managed Moves took place in your Local Authority between the years of 16-17 or 17-18 if this is available. Schools (including academies) are considered under the Freedom of Information Act (FOIA) to be public authorities in their own rights, and are subject to the FOIA in the same way as the council (albeit with different timescales to meet).
