Thank you for your request received on 19 August 2019, for the following information:

Please can you provide me with:

1. The names of the schools in your area that contain asbestos. Ideally, I would like this broken down into type of asbestos (white, brown and/or blue).

2. The date and outcome of the last independent audit or inspection of each of these schools Asbestos Management Plans.

3. The details of any reported incidents of asbestos exposure in these schools between 2010 and 2019.

4. Details of any improvement or prohibition notice served or guidance issued by the HSE in relation to the management of asbestos in schools in your area in the last 5 years.

5. The number of school employees (existing and retired staff to include teaching staff, school support staff and caretakers, etc) and ex-pupils that have pursued a claim against the Council for exposure to asbestos within a school in your area.

6. The number of these claims that have been settled.

7. The amount of money that has been paid in settlement of these claims (with and without your authority accepting responsibility).

8. The details of training offered to school governors, teachers or similar who carry out an inspection.

We have processed this request under the Environmental Information Regulations 2004.

#### Response

I am writing to inform you that we have searched our records and although we hold some of the information requested.

The responsibility for the council maintained schools (community schools) has been delegated to headteacher according to Barnet corporate arrangement.

All other schools i.e. Voluntary Aided, Academy are responsible to manage asbestos management on their site, the council do not have central system that holds information on asbestos in all the schools in one place. Where we do not hold information you will need to contact each schools directly.

Schools (including academies) are considered under the Freedom of Information Act (FOIA) to be public authorities in their own rights, and are subject to the FOIA in the same way as the council (albeit with different timescales to meet). It is therefore correct that the council does not hold this information, and that individual schools would need to be contacted.

The schools would be able to provide information on last independent audit commissioned by their site and the London Borough of Barnet would not hold this information. The ShaW team carries out a assurance review of compliance checks on the site and asbestos is small part of it. The ShaW team also carries out a asbestos management audit according to audit programme in the community schools and in the schools who have SLA with the ShaW team. The asbestos management audit outcome from the schools we have reviewed in last 5 years have always been over 75%. See attached spreadsheet.
