**PROPOSED TELECOMMUNICATIONS REMOVAL AND REPLACEMENT AT
CLAREMONT ROAD, BRENT CROSS, BARNET, LONDON, NW2 1AH (NGR: E: 523555
N: 187174)**

EE (UK) Ltd (EE) has an agreement with Hutchison 3G UK Limited (H3G) to consolidate part of their respective networks into a single network and rollout the next generation of technologies. As part of the delivery for 5G, EE and 3 are looking to install one pole within the area shown on the attached plan, close to the following postcode, N11 3DG. EE and H3G are in the process of upgrading and sharing various sites across the joint network, as it will allow two operators to provide coverage from various different technologies, including 5G from one shared pole.

I would be obliged if you would confirm the following:

- 1) What areas are highways maintainable land. Please can you provide an adoption records map?
- 2) If Barnet Council considers there could be any Health and Safety issues with the proposal in regards to the pole location.
- 3) Whether this part of the highway has an existing Section 58 Restriction Notice under the Traffic Management Act 2004 and if so, what is the expiry period?
- 4) Whether there any future plans for work to be undertaken using Section 58 Restriction Notice under the Traffic Management Act 2004.

We look forward to receiving your response within 14 days of this email. Please find attached an Article 13 that I am required to serve on you in relation to the Town and Country Planning (Development Management Procedure) (England) (as amended) confirming that an application for Full Planning is being submitted to London Borough of Barnet in respect of a proposed telecommunications installation at the above location.

We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

1) What areas are highways maintainable land. Please can you provide an adoption records map?

2) If Barnet Council considers there could be any Health and Safety issues with the proposal in regards to the pole location.

Any proposed works to replace/improve the Network Pole would need to be correctly assessed before assessments on H&S can be provided. The correct process would be to send any plans through to NRSWA@barnet.gov.uk where the team will assess and provide feedback

3) Whether this part of the highway has an existing Section 58 Restriction Notice under the Traffic Management Act 2004 and if so, what is the expiry period?

Carriageway Resurfacing (Part road - Prayle Grove to Clitthouse Road - southern entrance) expires 17/09/2019

Footway works and construction of 2 new accesses. (Part Road - Footway east side only from southern junction with Clitthouse Road to 85) expires 29/11/2019

4) Whether there any future plans for work to be undertaken using Section 58 Restriction Notice under the Traffic Management Act 2004.

We consider that the absolute exemption set out in Section 21 (Information accessible by other means) applies to the information requested because the information requested is already reasonably accessible elsewhere
