Refusal Notice

We are refusing part of your request (how long each site was occupied for and the cost per site) because we estimate that compliance with your request will exceed the "appropriate limit" under section 12.

The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx 23 plus hours to comply with your request for information about legal costs for how long each site was occupied for and the cost per site. Our calculation is as follows:

93 cases since January 2017 x 15 mins each= 23 plus hours.
