**4. Does the council service facilitate or take part in any hate crime forums?**

The Hate Crime Forum is a meeting that is held each quarter at Barnet Mencap's office. It is an opportunity for representatives of each of the Hate Crime Reporting Centres, representatives of other voluntary and community organisations who are concerned with community safety, safeguarding and well-being and the police to come together to discuss hate crime issues in Barnet. Members can raise concerns, share resources and draw on skills and knowledge of partners. It also gives members an opportunity to provide feedback to Barnet Council's Community Safety Team.

The first forum in 2018 took place on 20th April and included an introduction from Victim Support, a presentation from Barnet Council Engagement Group on their role within the community, a presentation by Inclusion Barnet on the People's Choice Safe Places Scheme and a focus on disability hate crime and the project Communications Campaign.

The second forum was on 27th July 2018 and included introductions from Hft and Community Barnet and focused on faith and religious hate crime with presentations from Tell Mama and Community Security Trust. The third forum was on 6th December 2018 and included a presentation by Inclusion Barnet on the conclusion of the People's Choice project and a focus on the implementation of the Victim Support Survey and work with the Police in 2019.

In addition, on Friday 19th October, the Barnet Multifaith Forum supported a key event at the Islamic Association of North London in North Finchley, highlighting the importance of Barnet's many faiths and cultures coming together to speak up against hate crime.

Last year we held a number of awareness-raising events across the borough. Barnet Council and the Metropolitan Police teamed up with Barnet Mencap, Victim Support and other community organisations including Community Barnet, Inclusion Barnet, Community Security Trust and Barnet Multifaith Forum to raise awareness around the reporting of hate crime.

At locations across the borough staff and volunteers talked to members of the public about identifying hate crime and the ways in which it can be reported to the Police. There was information about Barnet's Hate Crime Reporting Centres, where vulnerable adults can get support if they need assistance to speak up about hate crime. Over 250 people signed up to become Hate Crime Reporting Champions, pledging to report hate crime if they witness it. This will help the Police and Community Safety Teams target their resources and prevent hate crime from happening. Similar activity is planned for the 2019 Hate Crime awareness week.
