Thank you for your request received on 2 August 2019, for the following information:

Why at the Ballards Lane by The Grove Pedestrian Crossing are there no stems of tactile paving extending to the back of footway as stipulated in the government's 'Guidance on the use of Tactile Paving Surfaces'?

We have processed this request under the Environmental Information Regulations 2004.

Response

The council holds the information requested and the answers to your questions are below.

Why at the Ballards Lane by The Grove Pedestrian Crossing are there no stems of tactile paving extending to the back of footway as stipulated in the government's 'Guidance on the use of Tactile Paving Surfaces'?

Response

No information is held on the reason for the use of non-tactile paving.

Background to the Question

It appears that the footway on Ballards Lane beside the crossing was re-laid in 2008 or 2009 on the south-east side of Ballards Lane and in 2008 or earlier on the northwest side.

We do not have a record of the reason for the layout of the tactile paving at this location, but longer serving officers recall that the practice in Barnet at that time was to minimise the use of "tails" on tactile paving layouts.

Officers' recollection is that, at least in part, this was responding to concerns or perceived concerns that people with some conditions would find walking on tactile paving painful. The provision of tactile paving along the kerb primarily serves a safety purpose in alerting blind or partially sighted pedestrians to the change from

footway to carriageway. The "tail" on the paving, extending to the back of the footway helps guide people to the crossing point. The compromise was that provision would be made beside the kerb to address the safety aspect, but that the "tail" would be omitted.

Current practice in Barnet, at new installations and when footways are re-laid, is to provide tactile paving with "tails" in line with the guidance. If the absence of the "tail" at this particular crossing is making it hard for you or someone you know to locate the crossing please let us know. We may then be able to address this location in isolation from a small budget for making accessibility improvements, without waiting for the next major footway relay scheme.
