**Please can you provide me with the following information under the Freedom of Information act;**

- 1. How many CCTV cameras does the council own?**
- 2. Please specify how many of these are for the purposes of public space monitoring and how many are ANPR (number plate recognition) cameras.**
- 3. The location information for all public space monitoring and ANPR cameras the council owns. This can be in any format (ie. map, GPS coordinates, post codes, street names) that you are able to provide but higher accuracy information would be appreciated. I would also appreciate this information in a computer readable format as I use assistive technology so any format besides a scanned PDF is preferable please.**
- 4. When these cameras were last upgraded / installed.**
- 5. What the make / model of each camera is, or alternatively if known, what the resolution of each camera is.**
- 6. How you cameras connect back to the control centre, whether this be LoS Wi-Fi connection, BT Redcare circuits, or council maintained connectivity etc.**
- 7. Where your control centre is located.**

**I understand that this is a large number of questions and may take longer than the statutory time period to answer. If this becomes the case I would appreciate being informed as soon as possible and an indication of timelines for delivery provided.**

The council holds the information requested and it is attached/ the answers to your questions are below

### ***1.How many CCTV cameras does the council own?***

52 cameras at Oakleigh Depot

42 cameras at Colindale

28 cameras at Barnet House

Community safety Team – 128 Public space surveillance cameras and 20 ANPR cameras

***2. Please specify how many of these are for the purposes of public space monitoring and how many are ANPR (number plate recognition) cameras.***

Out of the 52 cameras at Oakleigh Depot, 50 are for the site and 2 are for ANPR

All 42 cameras at Colindale are for the site however 6 are PTZ cameras which covers the perimeter of the red line barrier.

All 28 cameras at Barnet House are for the site.

Community Safety Team- please see attached.

There are 20 ANPR cameras however these are owned by Barnet Council and on loan to the Met Police who manage the maintenance and constantly update the ANPR camera locations.

Parking Services- All parking Enforcement cameras use ANPR.

52 cameras at Oakleigh Depot – last serviced in August 2019

42 cameras at Colindale – installed in January 2019

28 cameras at Barnet House – last serviced in February 2019

Community Safety Team- please see attached.

Parking Services- This service is contracted to Videalert. 64 cameras at 32 locations.

**5. What the make / model of each camera is, or alternatively if known, what the resolution of each camera is.**

Cameras are AXIS M3104-L Network Cameras. Built in IR illumination. HDTV 720p video, WDR – Forensic Capture. Axis Zipstream technology.

Community Safety Team- please see attached.

Parking Services-This service is contracted to Videalert. The cameras are PADM58

**6. How you cameras connect back to the control center, whether this be LoS Wi-Fi connection, BT Redcare circuits, or council maintained connectivity etc.**

All council maintained activity for Oakleigh Depot, Barnet House and Colindale.

**Where your control center is located.**

All managed locally however the wider borough CCTV is managed by the Community Safety Team

Community Safety Team- please see attached. There are 117 360 vision predator cameras and 11 Axis P5635 e-mark 2

Parking Services- Videalert operate the CCTV for Parking Services and use their own server, the Videalert Rapidly deployable server system.
