Thank you for your request received on 19 August 2019, for the following information:

Please can I request under the Freedom of Information Act the following information in relation to any Private Finance Initiative contracts ever struck by yourselves:

1) For each contract, the projected total (whole life) cost of the scheme, in  $\pounds$ , detailed when the scheme was first agreed (i.e. the original projected cost of all Unitary Charge Payments over the full life of the scheme).

2) The projected total (whole life) cost of the scheme, in £, as at August 1, 2019 (i.e. the real cost for previous years and projected cost for future years of all Unitary Charge Payments over the full life of the scheme).

If there is a difference between A and B, please can you provide details of:

- a) The date(s) the projected costs changed
- b) The reason(s) the projected costs changed

Please can I also request:

3) A copy of the original contract/agreement;

4) An itemised list of any payments made to the PFI contractors for services not included in the original PFI deal, from the beginning of the deal to the current date, and to include exact details of what was being paid for.

If the following request cannot be met within cost limits, please can you provide me with guidance and assistance on how I may refine my request.

We have processed this request under the Freedom of Information Act 2000.

#### Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below.

#### Please can I request under the Freedom of Information Act the following

# *If the following request cannot be met within cost limits, please can you provide me with guidance and assistance on how I may refine my request.*

The only PFI initiative is the Street Lighting contract for all its street lighting, other illuminated street signs and bollards.

The PFI Service Provider is Barnet Lighting Services Limited (BLS). BLS subcontracts all the street lighting service to Bouygues Energies & Services (Bouygues E&S), formerly ETDE Infrastructure Limited (ETDE).

We consider that the qualified exemption set out in Section 43 (Prejudicial to commercial interests) subsection 2 applies to some of the information requested. Therefore, we have decided to withhold the rest of the information requested about the contract.

In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

### Factors in favour of disclosure

- Furthering the understanding, and participation in the public debate of issues
- facilitate the accountability and transparency of public authorities for decisions taken
- facilitate accountability and transparency in the spending of public money

• Allowing individuals to understand decisions made by public authorities affecting their lives and, in some cases, assist individuals in challenging those decisions

## Factors in favour of withholding

- Damage to business reputation or the confidence in customers or suppliers or investors may have in it,
- Detrimental impact on the commercial revenue of the councils and its contractors or threaten to secure finance and weaken position in a competitive environment
- Council position in a competitive environment, market sensitivity of information and potential usefulness to competitors
- Negative effect on competitiveness if competitors were to have access to this information

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
