Thank you for your request received on 27 August 2019, for the following information:

Taking the period from the start of 2015 to the current date, could you please release under the terms of the Freedom of Information Act:

- **the names of and links to supplementary planning documents adopted by the local authority, which were created using funding, in full or in part, by companies, consultancies and other organisations outside the local authority.**
- **the name or names of the organisations which funded them in each case**
- **the cash amount received by the council from each funder to cover the council's costs.**

We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exceptions apply to some of the information requested.

The remaining information is not withheld and is below

Taking the period from the start of 2015 to the current date, could you please release under the terms of the Freedom of Information Act:

- ***the names of and links to supplementary planning documents adopted by the local authority, which were created using funding, in full or in part, by companies, consultancies and other organisations outside the local authority.***
- ***the name or names of the organisations which funded them in each case***
- ***the cash amount received by the council from each funder to cover the council's costs.***

The Council has adopted 6 SPDs since 2015. These are set out at

The Council did not directly receive any funding for these SPDs.

Production of all these documents was overseen by Re, who are contracted by the Council to deliver planning services in Barnet.

In respect of area based SPDs for Grahame Park, North Finchley and Colindale Station Re was paid directly for this service via Planning Performance Agreements.

The Council did not therefore receive any cash from each of the funders.

We consider that Regulation 6(1)(b) applies to the information requested because the information requested is already publicly available and easily accessible.
