We have processed this request under the Freedom of Information Act 2000.

Response

Could I please request the following information:

- Which of these requested a full determination to change their school to a different religion, and which religion they chose***

Please note that only community schools must make a request to the Council. We have had no such requests.

Schools (including academies) are considered under the Freedom of Information Act (FOIA) to be public authorities in their own rights, and are subject to the FOIA in the same way as the council (albeit with different timescales to meet).
