Provide the following:

a. Traffic order that was prepared by the Council for the footway parking bays as part of the CPZ and the accompanying committee report. (Please do not send a generic report)

b. Data on pedestrian count on Elmer Gardens during the day and night on a typical weekday.

c. The Council's protocol on issuing PCN to vehicles, which stop briefly to drop passengers on restrictions that are in fact no waiting and NOT no stopping.

We have processed this request under the Freedom of Information Act 2000.

Response

I am writing to inform you that we have searched our records and although we hold some of the information requested, some is not held by London Borough of Barnet because Information is not recorded with regards to pedestrian counts.

We have provided answers to your request below showing where we do not hold the information requested.

Data is not recorded.

c. The Council's protocol on issuing PCN to vehicles, which stop briefly to drop passengers on restrictions that are in fact no waiting and NOT no stopping.

The council will issue penalties to vehicles parked on the footway in contravention of the footway parking ban irrespective of whether passengers are boarding or alighting. In other locations, where an exemption applies for boarding and alighting, a penalty would not be issued if this activity was observed.
