Thank you for your request received on 5 September 2019, for the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information.

In total, how many times has the council been taken to the Special Educational Needs and Disability (SEND) Tribunal in relation to a child's education, health and care (EHC) needs assessment or an EHC plan over the last five years (September 2014 to September 2019)?

Of these cases how many were for a refusal to:

- \* assess a child's EHC needs
- \* make a statement of their special educational needs
- \* reassess their special educational needs
- \* create an EHC plan
- \* change what's in a child's special educational needs statement or EHC plan
- \* maintain the statement or EHC plan

We have processed this request under the Freedom of Information Act 2000.

# Response

I am writing to you under the Freedom of Information Act 2000 to request the following information.

In total, how many times has the council been taken to the Special Educational Needs and Disability (SEND) Tribunal in relation to a child's education, health and care (EHC) needs assessment or an EHC plan over the last five years (September 2014 to September 2019)?

Of these cases how many were for a refusal to:

- assess a child's EHC needs
- make a statement of their special educational needs
- reassess their special educational needs
- create an EHC plan
- change what's in a child's special educational needs statement or EHC plan
- maintain the statement or EHC plan

No information held for 2014 - 2016

2016 – 2017: 30 2017 – 2018: 43 2018 – 2019: 71 2019 – Present: 72

Please note it is not possible to break down the information into the categories requested due to the time it would take to complete. In order for us to determine this information we would need to read the case notes for each appeal. From September 2016 to present, there have been 216 appeals to the SEND Tribunal. We estimate it would take approximately 10 minutes to read each appeal and determine the grounds for refusal.

Therefore, 216 (cases) x 10 minutes = 2,160 minutes (36 hours)

We have therefore decided to refuse your request, please see Refusal notice (Section 12) below.

### **Refusal Notice**

Section 12 of FOIA states that the council does not have to comply with a request for information if the cost of compliance exceeds the appropriate limit of £450 calculated at £25 per hour with a limit of 18 hours. The appropriate limit relates strictly to the process of determining whether the information is held; locating, retrieving and extracting the information, or a document containing it.
