There is no specific list of documents because every applicant has different circumstances, however we would expect the applicant to provide documents that prove they are in financial hardship and, as a result, cannot pay their Council Tax – for example bank statements, proof of income, evidence of debts they owe, evidence and details of their outgoings. We would also expect them to provide proof of any

medical or other circumstances or conditions that have contributed to their current situation, and how they have tried to mitigate their situation.
