Can you advise if it is one of yours and if there is any information attached that indicates it is unsafe, if so when did the tenancy end - tenants has advised they are living with family.

We have processed this request under the Environmental Information Regulations 2004.

Response

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

This information is held by Barnet Homes
