Contract management is devolved to service areas; discussions on modern slavery may take place through individual contract monitoring but the extent of this is not

collated centrally. Each contract contains clauses relating to modern slavery: namely that the service provider will make a statement under Section 54 of the Modern Slavery Act if required to do so and will report this to the Authority; that they warrant no activity constituting an offence under the Modern Slavery Act is occurring within their business or supply chain; if an offence occurs they will notify the Authority and that their contract may be terminated; and that they cooperate with the Authority in respect of S52 of the Modern Slavery Act (Duty to notify Secretary of State about suspected victims of slavery or human trafficking).
