Thank you for your request received on 13 September 2019, for the following information:

I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act. In order to assist you with this request, I am outlining my query as specifically as possible. If however this request is too wide or too unclear, I would be grateful if you could contact me as I understand that under the Act, you are required to advise and assist requesters. Can you please provide me with a list of 'specified injuries' (<a href="http://www.hse.gov.uk/riddor/specified-injuries.htm">http://www.hse.gov.uk/riddor/specified-injuries.htm</a>) reported to you under the Reporting of Injuries, Disease and Dangerous Occurrences Regulations (RIDDOR) as part of your responsibilities under The Health and Safety (Enforcing Authority) Regulations 1998. I would like to receive the data from 2014 to the current day, with the information provided in a series of columns detailing:

- 1/ The date of the incident.
- 2/ The injured party's age.
- 3/ The specified injury sustained (bone fracture, amputation, blinding, crush, serious burns, scalping, loss of consciousness, injuries associated with working in an enclosed space).
- 4/ The industry sector.
- 5/ The name of organisation where the injury occurred.
- 6/ The post code where the injury was sustained.
- 7/ If the incident was investigated by the Local Authority or not.

I would be grateful if you could confirm in writing that you have received this request. I look forward to hearing from you.

#### Response

We have processed this request under the Freedom of Information Act 2000.

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exceptions apply to some of the information requested. The remaining information is not withheld and is attached.

Can you please provide me with a list of 'specified injuries' (

I would like to receive the data from 2014 to the current day, with the information provided in a series of columns detailing:

- 1/ The date of the incident.
- 2/ The injured party's age.
- 3/ The specified injury sustained (bone fracture, amputation, blinding, crush, serious burns, scalping, loss of consciousness, injuries associated with working in an enclosed space).
- 4/ The industry sector.
- 5/ The name of organisation where the injury occurred.
- 6/ The post code where the injury was sustained.
- 7/ If the incident was investigated by the Local Authority or not.

We consider that Section 40 sub section 2 (Personal information) applies to some of the information requested.

To ensure that no personal sensitive or individual identify information was released we have check each data record before release. Our General Data Protection Regulation (GDPR) or Data Protection Act 2018 (DPA) related concerns would be to assure ourselves that the information released would not allow a specific individual to be identified. This is because many reports will relate to small employers, or even individuals, and when taken alongside location details (eg postcode, Local Authority), there could be disclosure issues especially if the premises employ only a few workers. Where this is the case I have provided a partial postcode and removed the name of the Trading Name.

We would wish to ensure that any disclosure would not compromise an on-going investigation or any formal enforcement/court action that may be in progress. Again only a partial postcode is provided and no details of the Trading Name.

Therefore we have decided to withhold some of the information.

# **Refusal Notice Section 40(2)**

Part 1 of Schedule 19 of the Data Protection Act 2018 amends the personal data exemption under section 40 of the Freedom of Information Act 2000(FOI). These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They

will not fundamentally impact when personal data can, and cannot, be disclosed in response to an FOI request.

Personal Information is governed by the Data Protection Act legislation and is defined as any information relating to an identified or identifiable natural person ('data subject')". It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness. The reasons why it is unfair in this case eg it would allow children to be identified/ it would allow planning complainants to be identified where they have complained expecting their details
