I am writing to inform you that we have searched our records and although we hold some of the information requested, some is not held by London Borough of Barnet because the revenue data is not avaliable as of the date this response is generated.

We have provided answers to your request below showing where we do not hold the information requested.

- 30 Business permits.

- 62 Business parking spaces.

- 1559 Resident parking permits.

04 How many residents parking spaces are there for the NW4 postcode from 01.01.2019 ' 31.12.2019

- 841 Resident parking spaces.
