Thank you for your request received on 27 September 2019, for the following information:

In the planning application 17/4102/FUL there are documents which form part of the development's requirements, as also mentioned in APP/N5090/W/18/3197652 as Tree Protection Plan 992-01 revision B. In 4.11.1 is details of information required.

Can I please have all information available regarding the conditions specified in 4.11.1 including, but there may be more, the Arboricultural Method Statement, any issues that may have arisen (details and correspondence) and the details of each site visit.

We have processed this request under the Environmental Information Regulations 2004.

Response

In the planning application 17/4102/FUL there are documents which form part of the development's requirements, as also mentioned in APP/N5090/W/18/3197652 as Tree Protection Plan 992-01 revision B. In 4.11.1 is details of information required.

Can I please have all information available regarding the conditions specified in 4.11.1 including, but there may be more, the Arboricultural Method Statement, any issues that may have arisen (details and correspondence) and the details of each site visit.

Condition 2 of the appeal decision (reference APP/N5090/W/18/3197652) sets out the plans in accordance with which the development shall be carried out. Condition 2 did not specify the Arboricultural Impact Assessment report, only the tree protection plan within that (Tree Protection Plan 992-01 revision B). Therefore, there is no requirement to produce the information set out in Paragraph 4.11.1.

Page 12 of the attached document contains the plan referred to Tree Protection Plan 992-01 revision B

The only other reference to trees within the appeal decision is condition 8. This requires the provision of tree protection fencing during development to be implemented in accordance with the Arboricultural Impact Assessment available on the planning application 17/4102/FUL at <https://publicaccess.barnet.gov.uk/online-applications/>
