Thank you for your request received on 22 October 2019, for the following information:

Under the Freedom of Information Act 2000 I hereby submit a Request that a) you release to me all available information as to what is happening with this School, how this suspension came about, after so many decades of successful operation in the London Borough of Barnet. b) I understand from your terms of reference that your duties include working in partnership (i.e. in consultation) with Head Teachers. If so, what consultation and when did you have with the Head Teacher of the Greek School prior to your visit to the School? (The School operates legally from Totteridge Academy since 1990 but their relationship is that of a tenant paying rent and is not operating under the Head and Teaching Staff of TTA). c) I know that there are 4 other Christian Greek Community Schools operating in the London Borough of Barnet, besides of course other Community or faith Schools, be they Christian, Jewish, or Muslim or others. Therefore I would like to know whether same sudden visits have taken place with regard to all other Community schools in the London Borough of Barnet, same treatment applied, before or after the decision for the sudden suspension of Manor Hill School and when, giving me particulars of such visits and if such visits have not taken place, why not. If yes, when, and what was the result for each and every one of them.

We have processed this request under the Freedom of Information Act 2000.

Response

The council has not suspended the school. The decision to suspend the school was taken either by Totteridge Academy or the United Learning Trust who are responsible for the Academy. If you require any further information I suggest you direct your enquiries to the school or the Trust:
